Temporary and Disability Assistance Statistics **JANUARY 2012**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 565,870 in January 2012, decreasing by 4,902 (-0.9%) from the previous month. Related expenditures totaled \$171,798,475 in January 2012, decreasing by approximately \$8.7 million (-4.8%) over December 2011.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,059,120 in January 2012, decreasing by 9,455 (-0.3%) from the previous month. Food Stamp expenditures totaled \$451,574,668 in January 2012, decreasing by approximately \$8.6 million (-1.9%) over December 2011.

Supplemental Security Income

Supplemental Security Income: For January 2012, SSI recipients (including Mental Hygiene) totaled 697,721 increasing by 4,438 (+0.6%) from the previous month. SSI expenditures in January 2012 totaled \$401,706,968 increasing by approximately \$13.8 million (+3.5%) over December 2011.

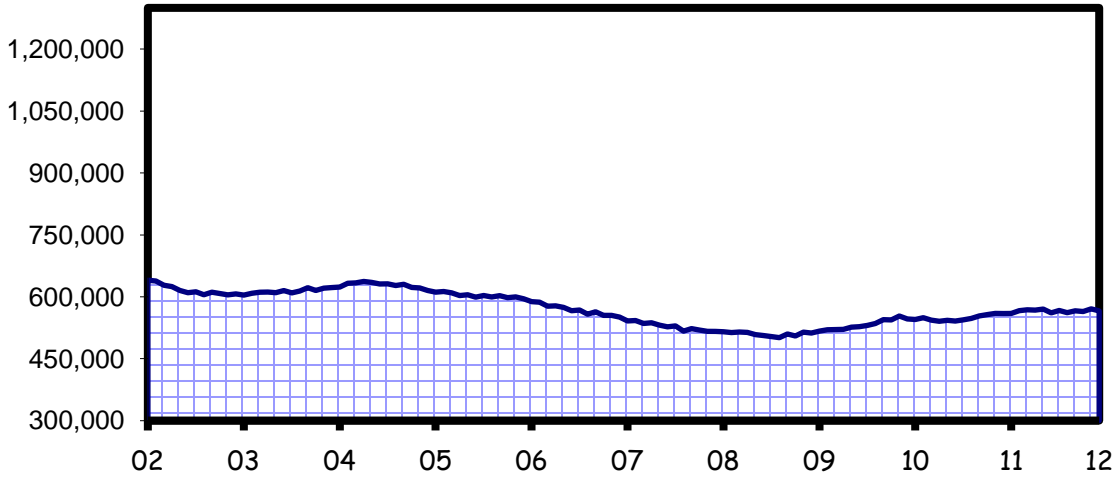

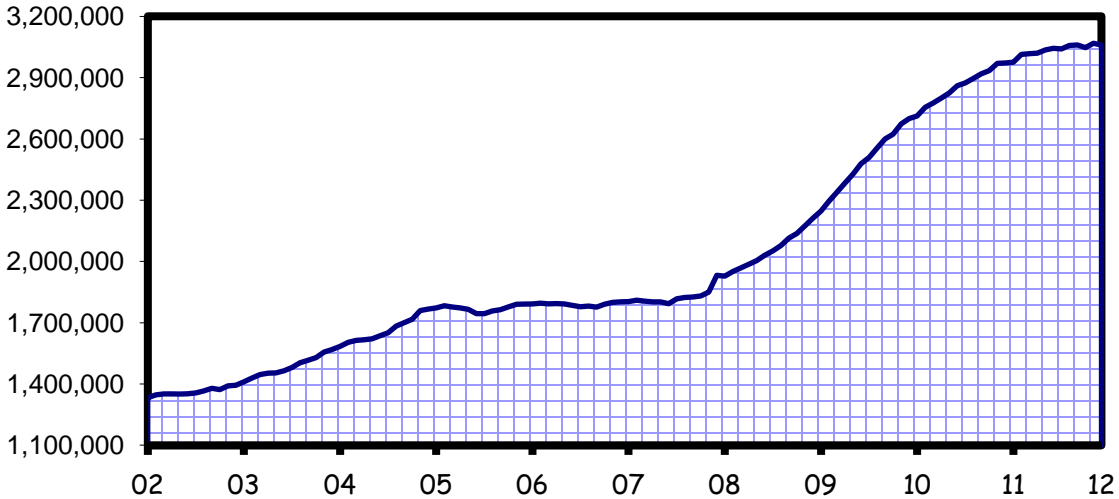

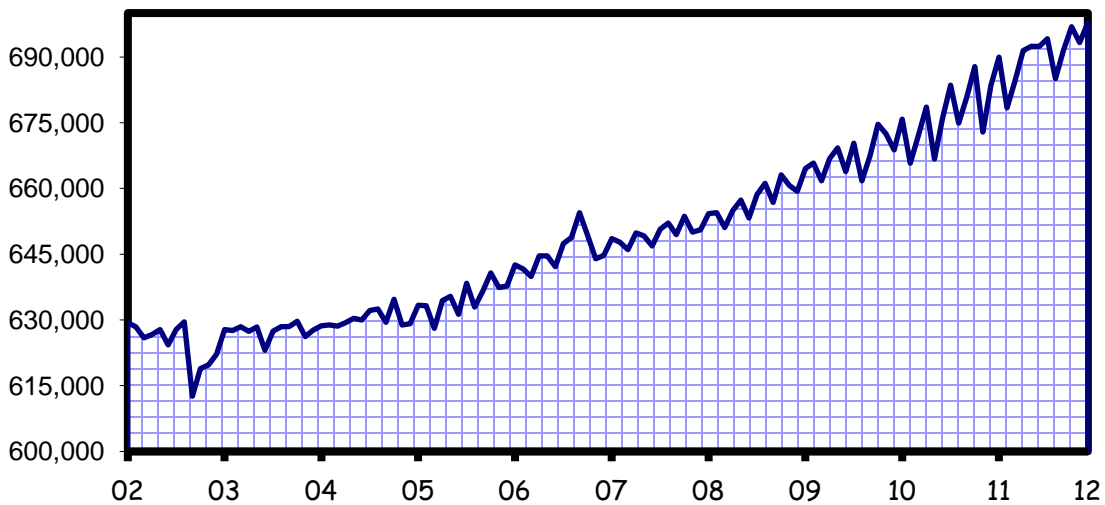
