Temporary and Disability Assistance Statistics **FEBRUARY 2012**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 567,134 in February 2012, increasing by 1,264 (+0.2%) from the previous month. Related expenditures totaled \$176,767,670 in February 2012, increasing by approximately \$4.97 million (+2.9%) over January 2012.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,059,262 in February 2012, increasing by 142 (+0.005%) from the previous month. Food Stamp expenditures totaled \$453,809,061 in February 2012, increasing by approximately \$2.2 million (+0.5%) over January 2012.

Supplemental Security Income

Supplemental Security Income: For February 2012, SSI recipients (including Mental Hygiene) totaled 696,485 decreasing by 1,236 (-0.2%) from the previous month. SSI expenditures in February 2012 totaled \$401,799,553 increasing by 92,585 (+0.02%) over January 2012.

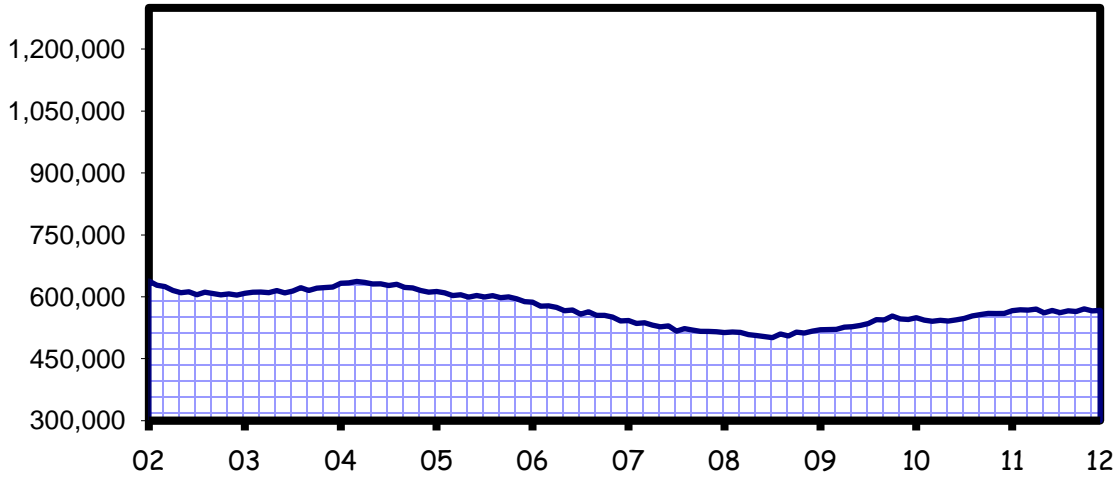

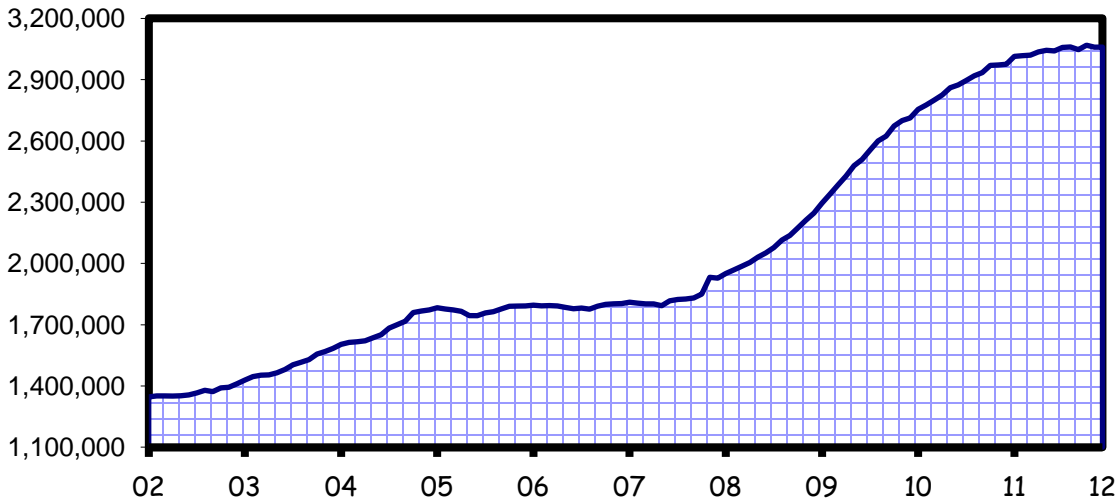

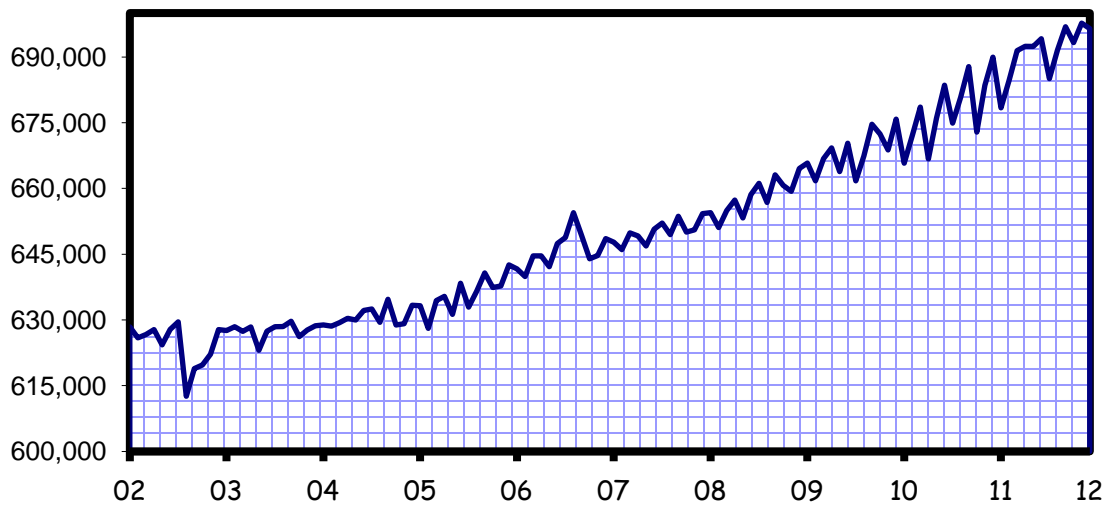
