Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 589,725 in April 2013, increasing by 3,963 (+0.7%) from the previous month. Related expenditures totaled \$192,959,485 in April 2013, increasing by approximately \$2.2 million (+1.2%) over March 2013.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,181,218 in April 2013, decreasing by 1,758 (-0.1%) from the previous month. Related expenditures totaled \$465,214,254 in April 2013, decreasing by approximately \$1.4 million (-0.3%) over March 2013.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 698,454 in April 2013, increasing by 7,835 (+1.1%) from the previous month. Related expenditures totaled \$412,535,500 in April 2013, increasing by approximately \$11.7 million (+2.9%) over March 2013.

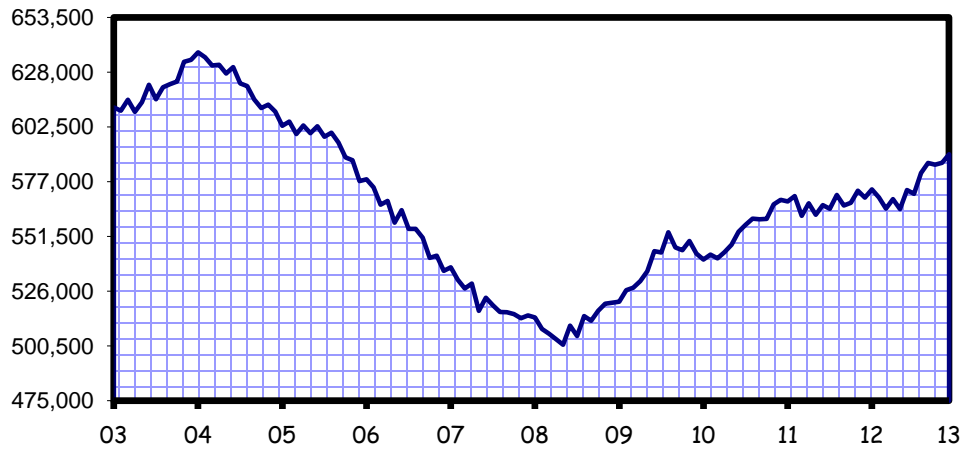

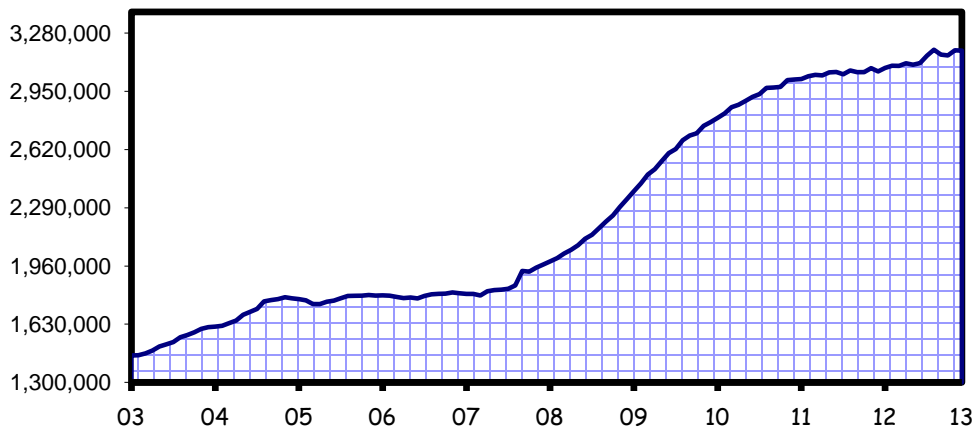

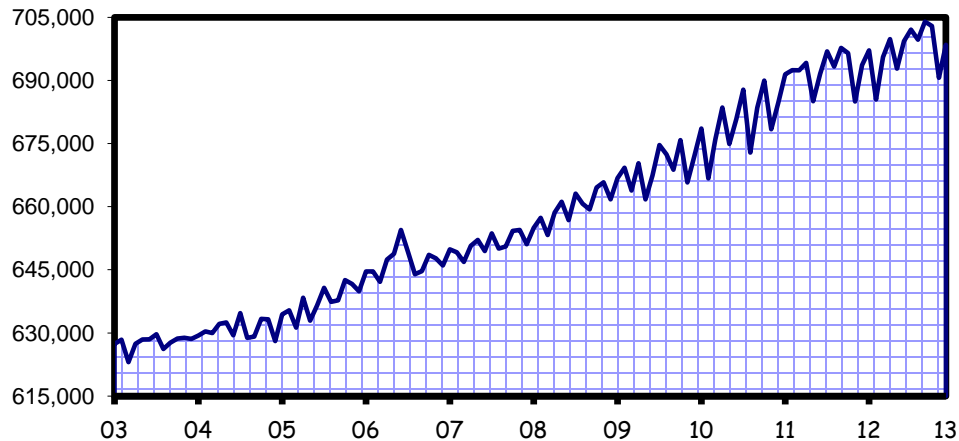
