# **Temporary and Disability Assistance Statistics**

## **MAY 2013**

---

### **Temporary Assistance**

Temporary Assistance: Temporary Assistance recipients totaled 587,316 in May 2013, decreasing by 2,409 (-0.4%) from the previous month. Related expenditures totaled \$193,999,976 in May 2013, increasing by approximately \$1.0 million (+0.5%) over April 2013.

### **Supplemental Nutrition Assistance Program**

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,183,287 in May 2013, increasing by 2,069 (+0.1%) from the previous month. Related expenditures totaled \$466,002,444 in May 2013, increasing by \$788,190 (+0.2%) over April 2013.

### **Supplemental Security Income**

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 701,949 in May 2013, increasing by 3,495 (+0.5%) from the previous month. Related expenditures totaled \$410,008,218 in May 2013, decreasing by approximately \$2.5 million (-0.6%) over April 2013.

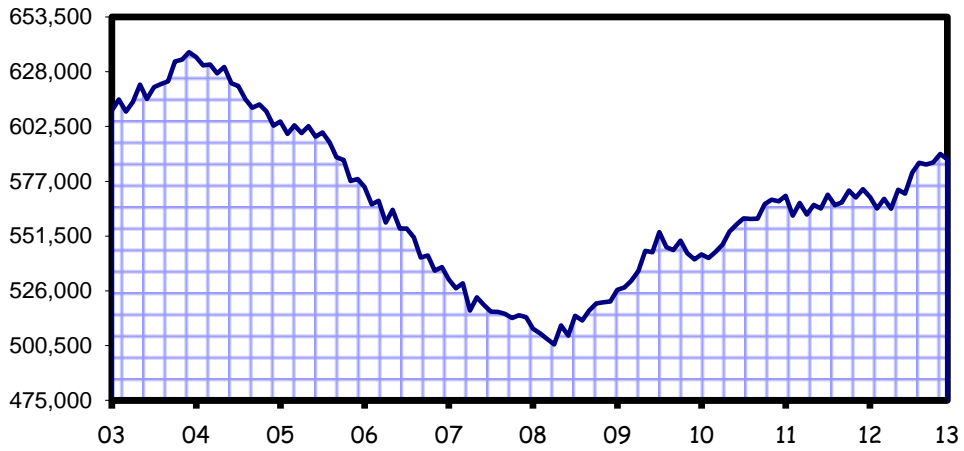

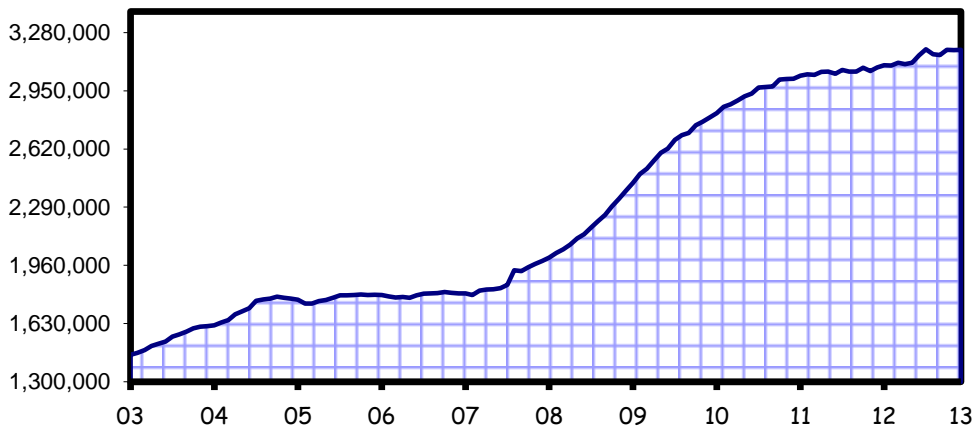

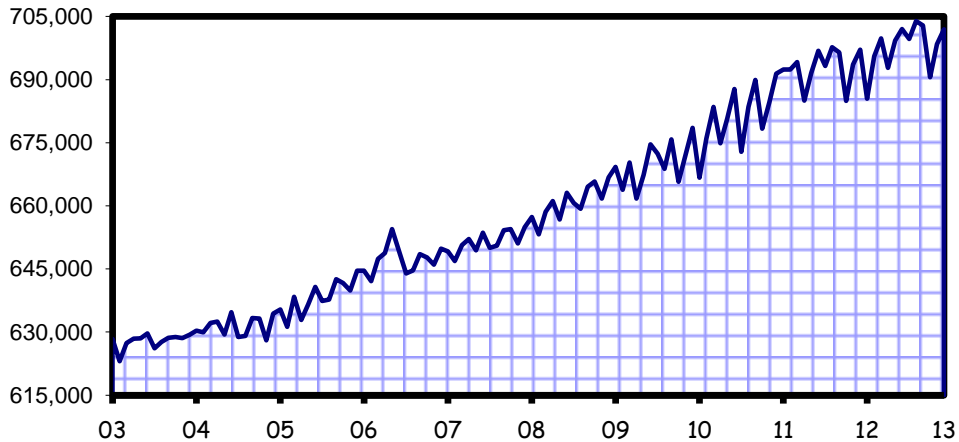
