Temporary and Disability Assistance Statistics

JUNE 2013

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 580,109 in June 2013, decreasing by 7,207 (-1.2%) from the previous month. Related expenditures totaled \$185,009,458 in June 2013, decreasing by approximately \$9.0 million (-4.6%) over May 2013.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,186,788 in June 2013, increasing by 3,501 (+0.1%) from the previous month. Related expenditures totaled \$465,462,682 in June 2013, decreasing by \$539,762 (-0.1%) over May 2013.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 689,891 in June 2013, decreasing by 12,058 (-1.7%) from the previous month. Related expenditures totaled \$399,844,830 in June 2013, decreasing by approximately \$10.2 million (-2.5%) over May 2013.

Note: Beginning in June 2013, New York City began revisions to their Temporary Assistance (TA) reporting methodology to better identify cases eligible for the Temporary Assistance for Needy Families (TANF) program. While overall caseload counts are not affected, the distribution among case categories is, resulting in higher TANF counts and lower Safety Net Assistance Maintenance of Effort counts than would otherwise have been reported absent the change. For this report, case and recipient counts as well as expenditure data reflect these changes. Therefore, it is advised to use caution when using the New York City TA case classification and expenditure data for any trending purpose.

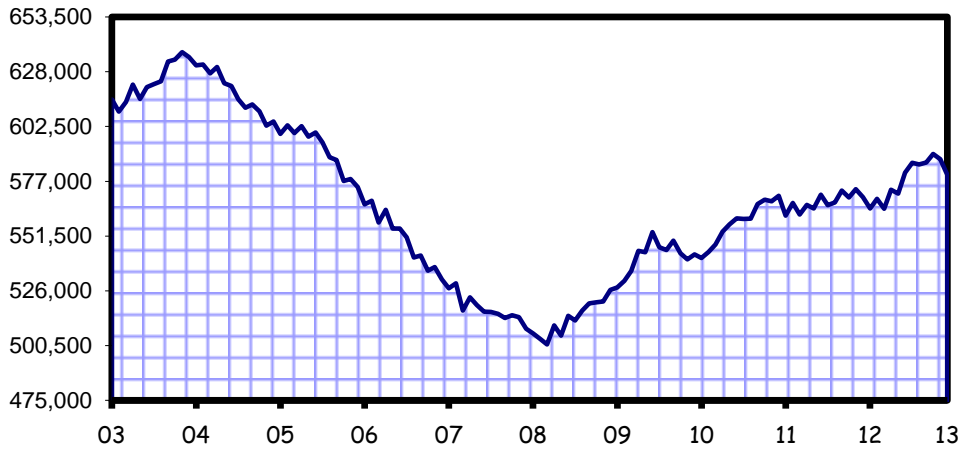

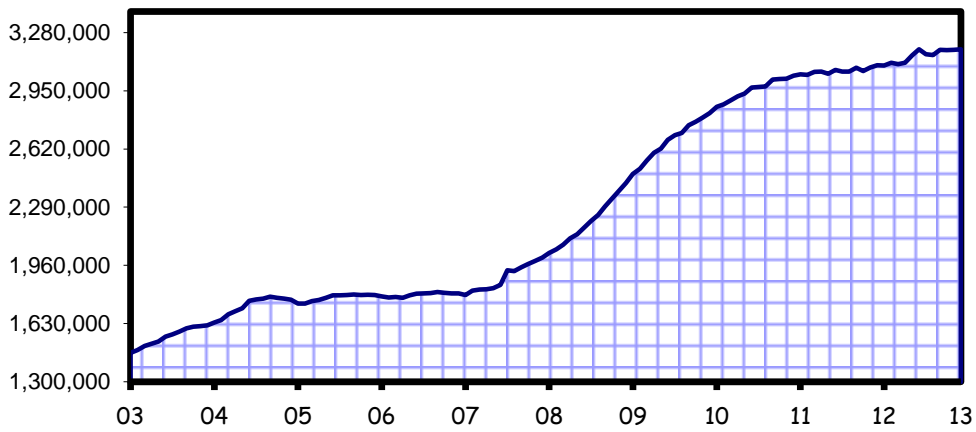

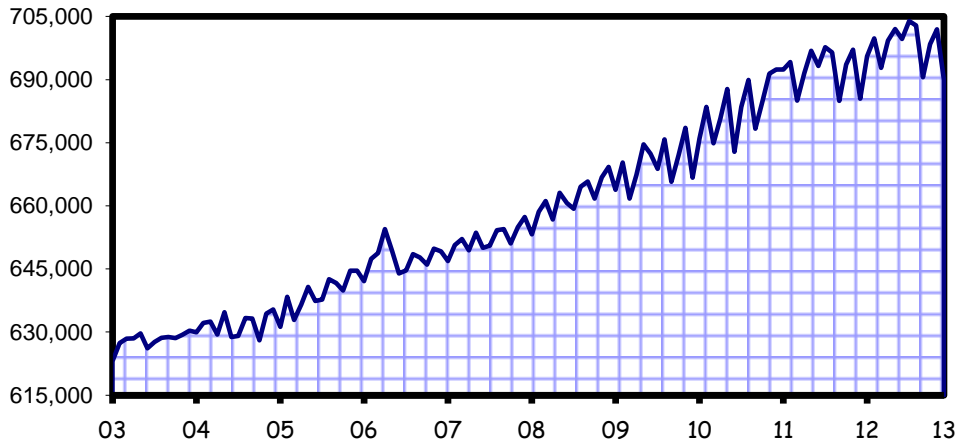
