SEPTEMBER 2013

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 569,174 in September 2013, decreasing by 4,661 (-0.8%) from the previous month. Related expenditures totaled \$179,660,720 in September 2013, decreasing by approximately \$4.4 million (-2.4%) over August 2013.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,169,363 in September 2013, decreasing by 17,167 (-0.5%) from the previous month. Related expenditures totaled \$462,307,324 in September 2013, decreasing by approximately \$3.9 million (-0.8%) over August 2013.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 692,572 in September 2013, decreasing by 11,152 (-1.6%) from the previous month. Related expenditures totaled \$402,527,920 in September 2013, decreasing by approximately \$8.7 million (-2.1%) over August 2013.

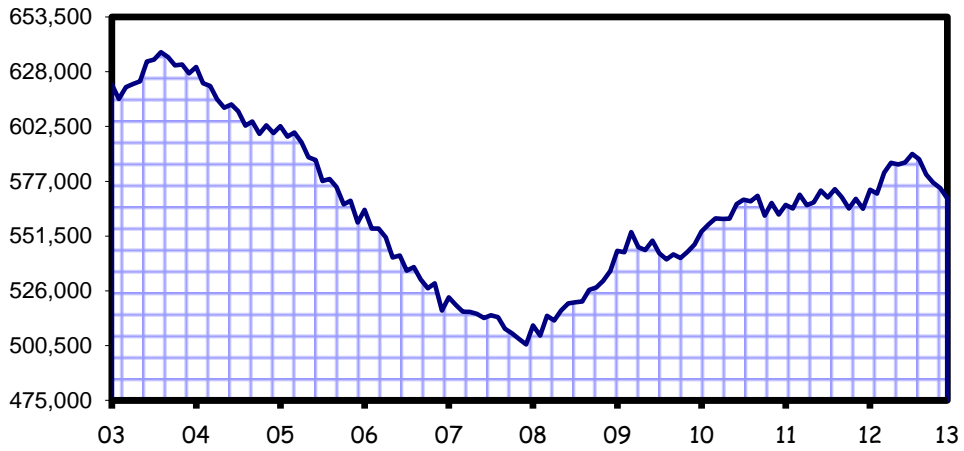

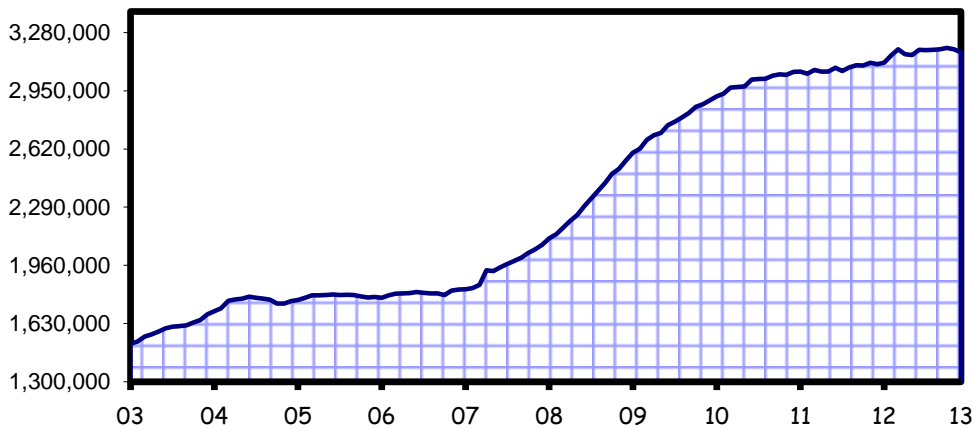

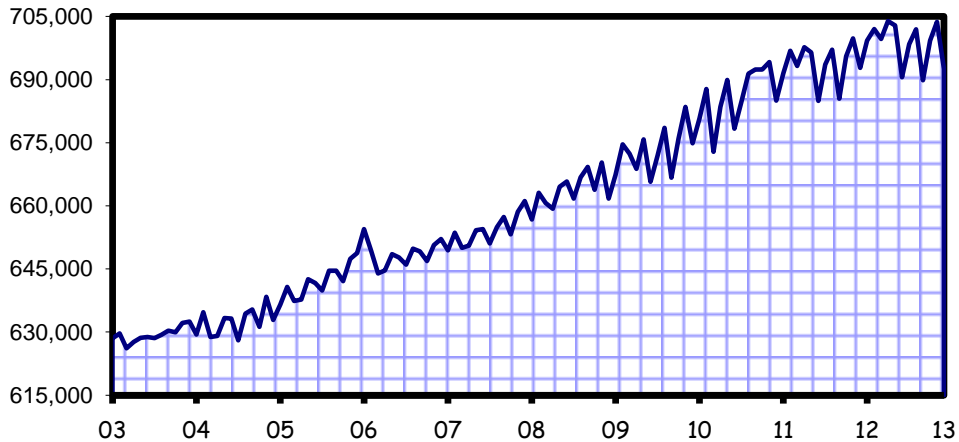
