## Temporary and Disability Assistance Statistics NOVEMBER 2013

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 568,983 in November 2013, decreasing by 4,309 (-0.8%) from the previous month. Related expenditures totaled \$179,695,775 in November 2013, decreasing by approximately \$7.6 million (-4.0%) over October 2013.

### Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,243,156 in November 2013, increasing by 72,833 (+2.3%) from the previous month. Related expenditures totaled \$529,511,752 in November 2013, increasing by approximately \$61.2 million (+13.1%) over October 2013.

### Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 704,069 in November 2013, increasing by 3,340 (+0.5%) from the previous month. Related expenditures totaled \$407,295,060 in November 2013, increasing by \$756,660 (+0.2%) over October 2013.

**Note:** In November the Office of Temporary and Disability Assistance issued one-time Supplemental Nutrition Assistance Program (SNAP) payments as part of a litigation settlement. These payments went to both current and former recipients of SNAP, substantially increasing the benefit, household, and recipient numbers over what they would have been in the absence of the payments. Also, SNAP benefit decreases resulting from the expiration of the enhanced benefit levels instituted as part of the American Recovery and Reinvestment Act went into full effect in November, and partially offset the benefit increase caused by the settlement. Thus, November SNAP data should be interpreted with caution.

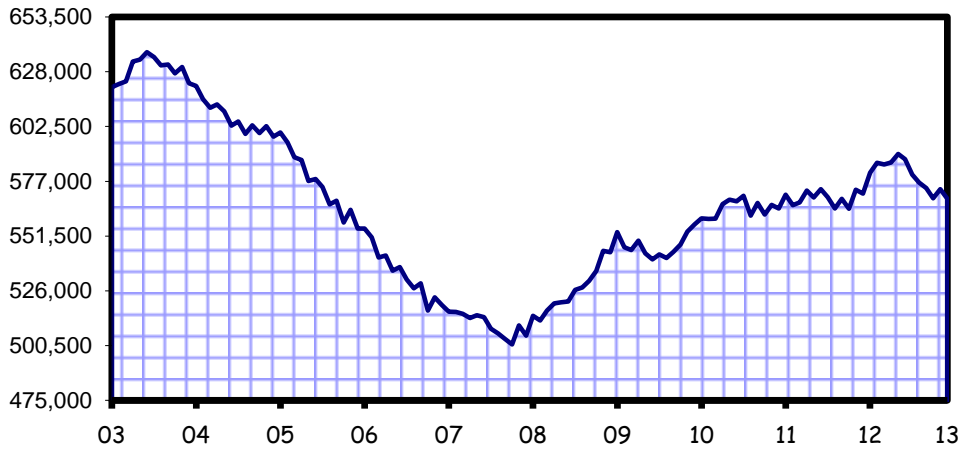

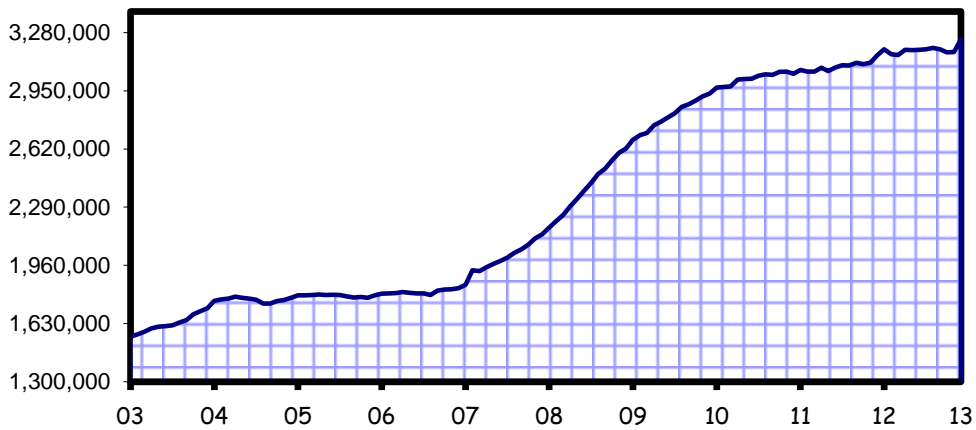

TEN YEAR TREND**

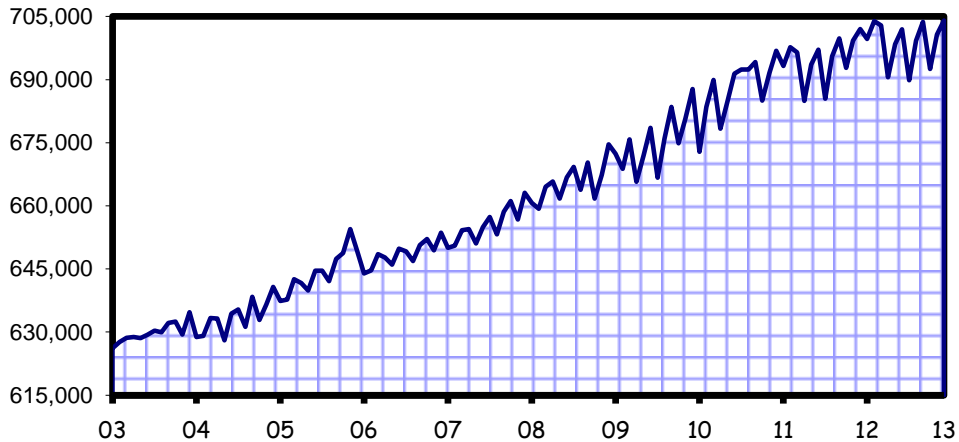
