Temporary and Disability Assistance Statistics **February 2014**

Temporary Assistance

Temporary Assistance recipients totaled 561,525 in February 2014, increasing by 534 (+0.1%) from the previous month. Related expenditures totaled \$178,536,108 in February 2014, decreasing by \$151,678 (-0.1%) over January 2014.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,114,414 in February 2014, decreasing by 34,118 (-1.1%) from the previous month. Related expenditures totaled \$427,199,723 in February 2014, decreasing by approximately \$4.3 million (-1.0%) over January 2014.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 702,643 in February 2014, increasing by 3,151 (+0.5%) from the previous month. Related expenditures totaled \$412,336,397 in February 2014, increasing by approximately \$4.4 million (+1.1%) over January 2014.

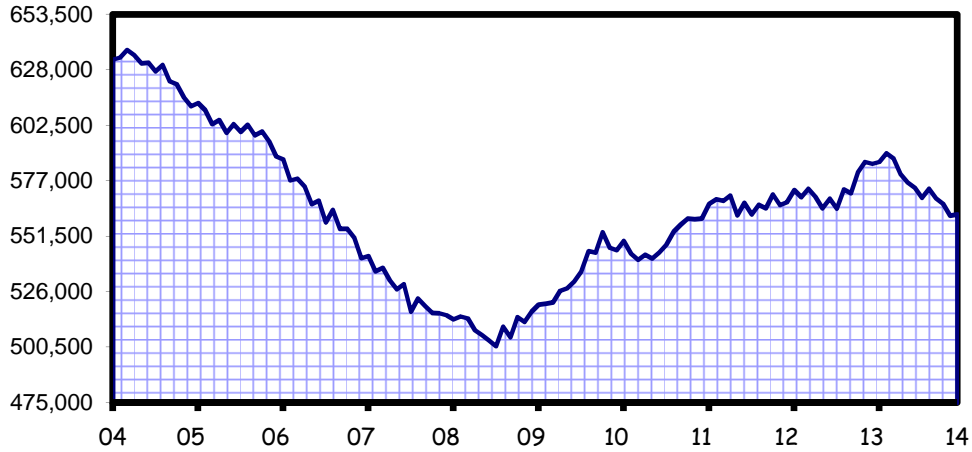

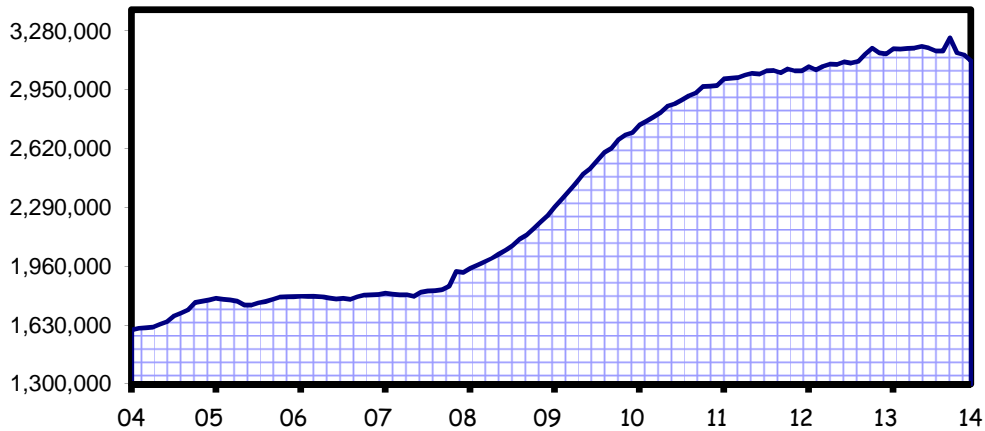

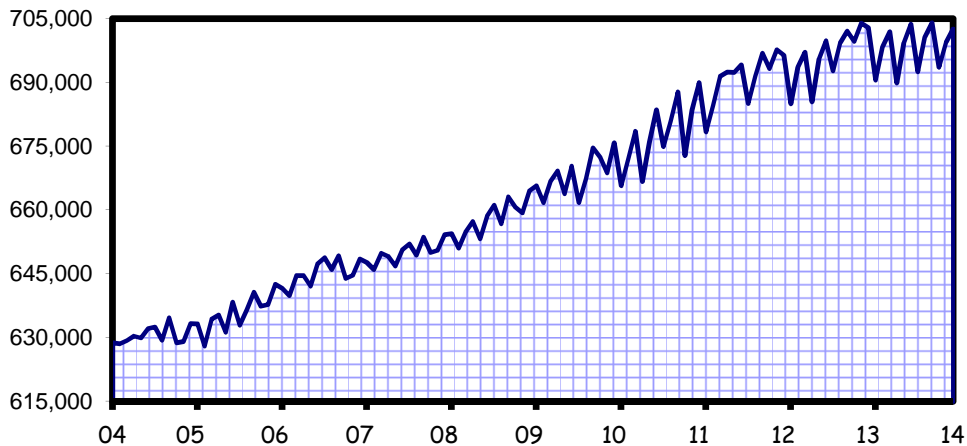
