Temporary Assistance

Temporary Assistance recipients totaled 563,201 in June 2014, decreasing by 1,411 (-0.2%) from the previous month. Related expenditures totaled \$182,454,024 in June 2014, decreasing by approximately \$4.0 million (-2.1%) over May 2014.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,094,747 in June 2014, decreasing by 7,141 (-0.2%) from the previous month. Related expenditures totaled \$426,629,836 in June 2014, decreasing by approximately \$2.3 million (-0.5%) over May 2014.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 692,359 in June 2014, decreasing by 10,295 (-1.5%) from the previous month. Related expenditures totaled \$408,579,936 in June 2014, decreasing by approximately \$7.0 million (-1.7%) over May 2014.

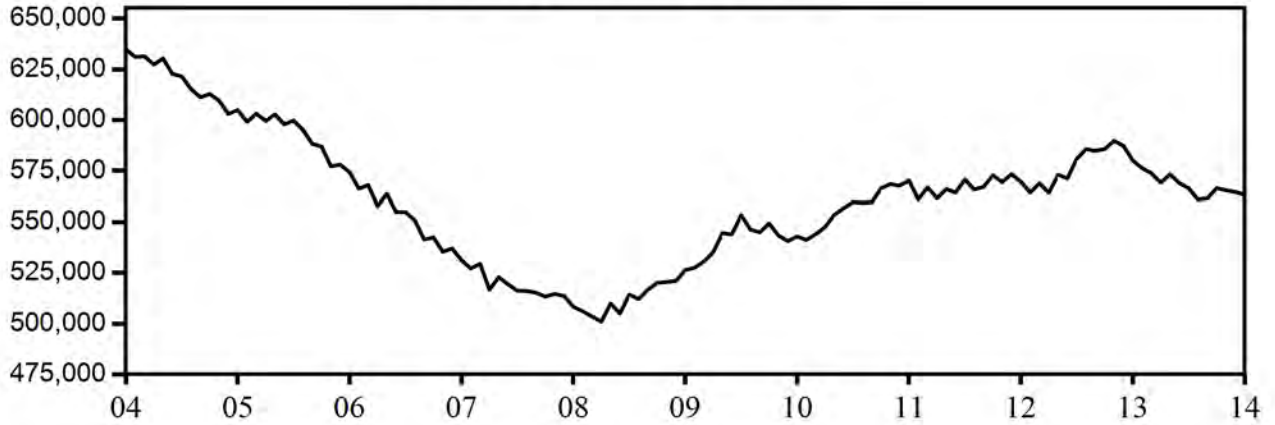

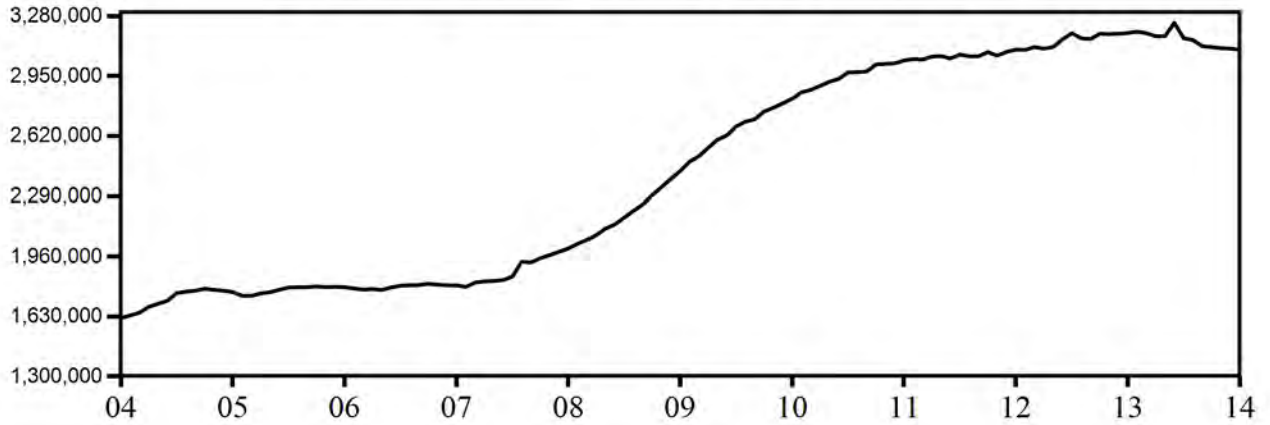

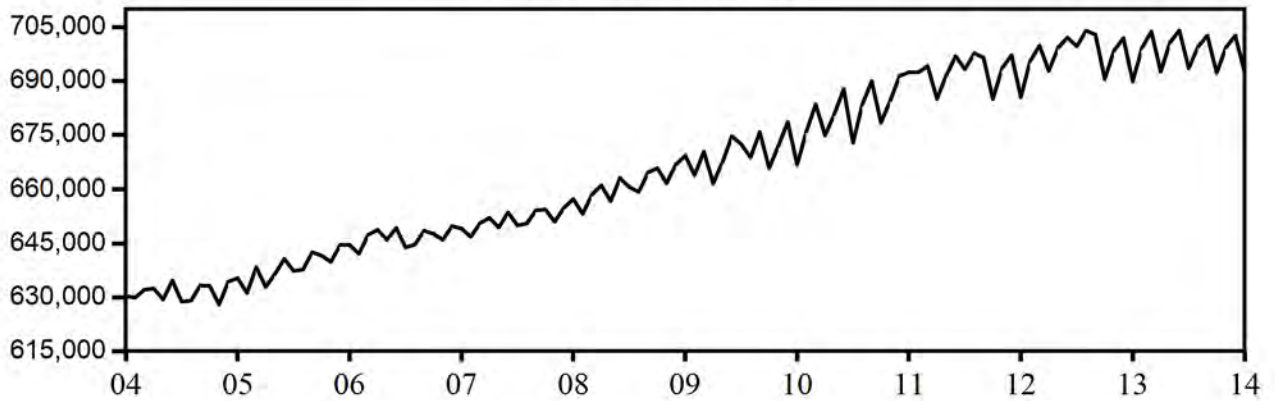
