Temporary Assistance

Temporary Assistance recipients totaled 562,676 in July 2014, decreasing by 525 (-0.1%) from the previous month. Related expenditures totaled \$183,334,852 in July 2014, increasing by \$880,828 (+0.5%) over June 2014.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,088,298 in July 2014, decreasing by 6,449 (-0.2%) from the previous month. Related expenditures totaled \$425,669,802 in July 2014, decreasing by \$960,034 (-0.2%) over June 2014.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 697,638 in July 2014, increasing by 5,279 (+0.8%) from the previous month. Related expenditures totaled \$408,615,624 in July 2014, increasing by \$35,688 (+0.01%) over June 2014.

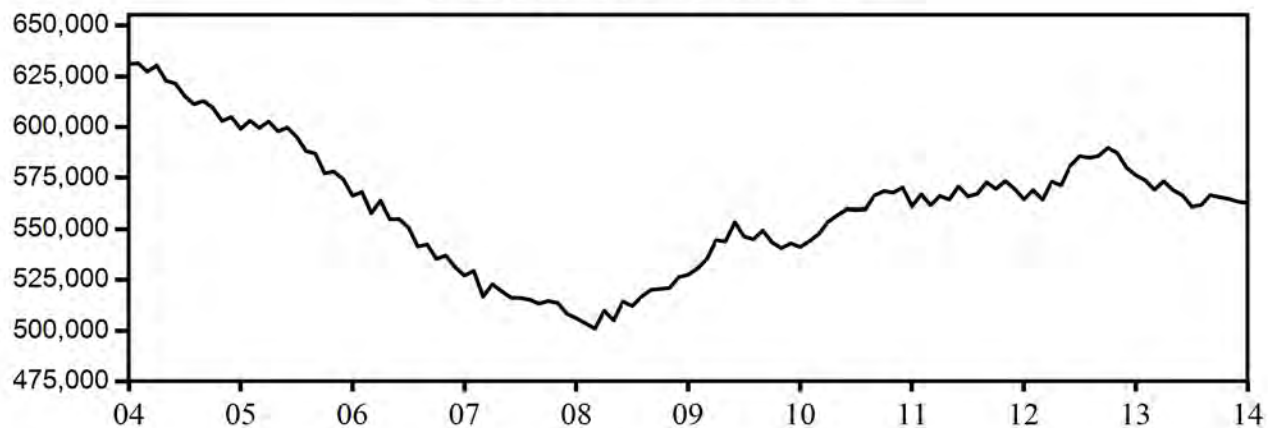

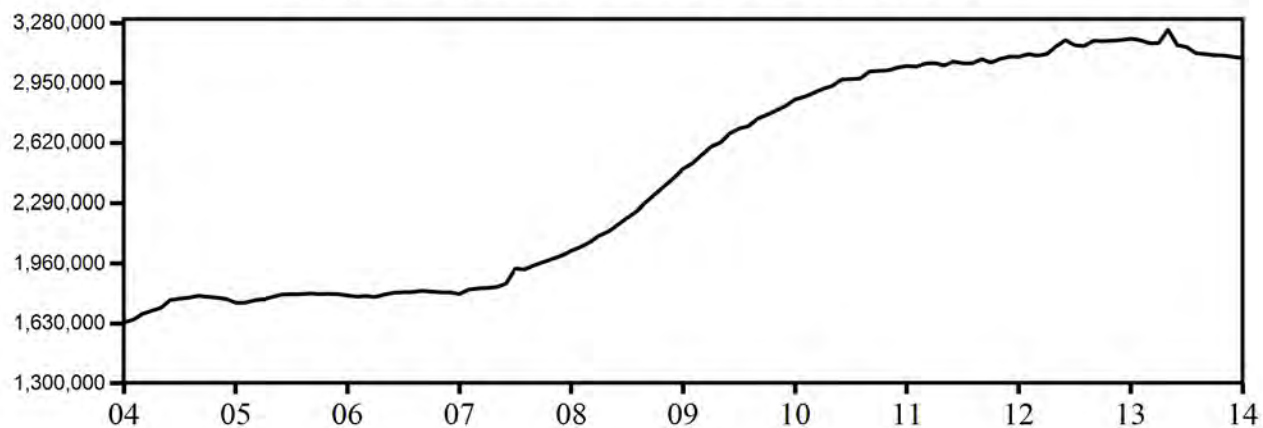

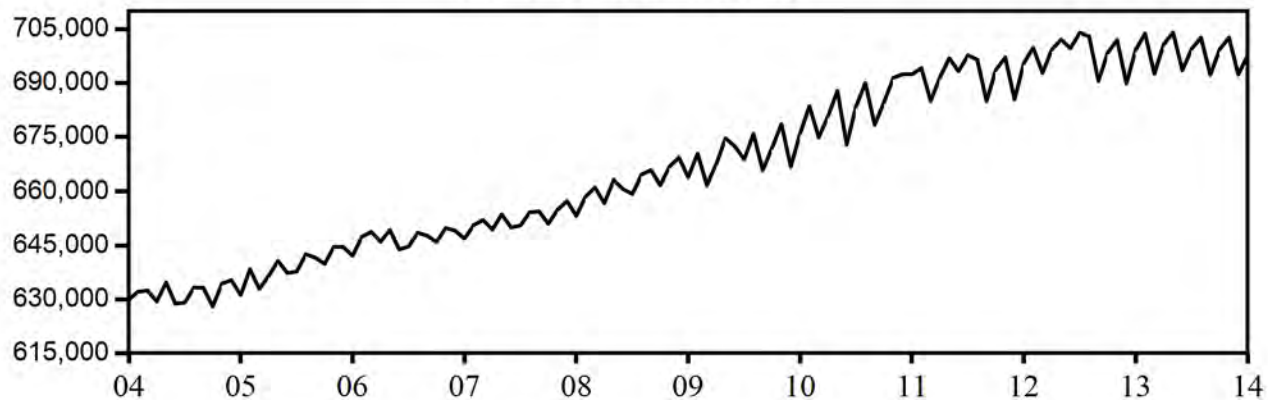
