Description: The Supplemental Nutrition Assistance Nutrition Education Program (SNAP-Ed), is funded by a grant from the United States Department of Agriculture. The program is authorized by Section 241 of the Healthy, Hunger-Free Kids Act of 2010 (Public Law 111-296). The program provides funding for community-based nutrition education and obesity prevention activities targeted to SNAP and SNAP eligible populations. These activities are required to utilize a variety of education strategies, including policy and environmental approaches, with the goal of facilitating voluntary adoption of healthy nutrition and physical activity behaviors conducive to the positive health and well-being of individuals eligible for SNAP and other means-tested federal assistance programs.

Grants will be provided to public or private not-for-profit agencies and organizations located in and conducting business in New York State, including, but not limited to, community-based organizations, Cornell Cooperative Extensions, regional health care organizations, and academic institutions. All applicants must be prequalified with the Grants Gateway.
