Description: The New York State (NYS) Office of Temporary and Disability Assistance (OTDA) announces a funding opportunity from the New York State homeless housing programs fund appropriated in the State Fiscal Year (SFY) 2015-16 Aid to Localities budget for the New York State Supportive Housing Program (NYSSHP). OTDA will make funding available statewide for eligible projects. Applications will be accepted from units of local government, local social services districts, tribal organizations and not-for-profit corporations. The New York State Supportive Housing Program (NYSSHP) is designed to provide direct services to eligible populations residing in permanent or transitional housing projects managed by eligible applicants. NYSSHP funds support the cost of providing services designed to promote housing stability and greater independence including, employability, mental/physical health stability and/or academic attainment. The support services provided should assist residents in achieving as self-sufficient a life possible while enhancing housing stability.
