The purpose of this Informational Letter (INF) is to provide social services districts with an updated chart which summarizes the major components of the various funding sources available for the provision of child care services. A list of relevant Department releases also is provided. This INF replaces 92 INF-10.

Currently, several funding sources are available for the provision of child care services to low income families in New York State. Some of these programs are mandated, while others are optional programs in which social services districts may elect to participate. Programs vary in the purposes for which child care is provided, ages of children who may be served, providers eligible for reimbursement, and the source and levels of reimbursement available to social services districts.

Attachment A, "Child Care Funding: Relevant Releases," is a program-specific list of Department releases which detail programmatic and claiming information.

Attachment B, "Child Care Programs (Rev. 4/94)", is designed to assist social services districts in differentiating between the various funding sources. This chart provides regulatory citations and summarizes key factors of financial and programmatic eligibility, eligible child, eligible providers, rates, funding reimbursement and fees for each of the child care programs available in New York State. The chart has been updated to reflect changes in program rules since its original release.
