The Bureau of Local Financial Operations and the Office of Human Resource Development will be presenting a training session in which the changes to the Financial Claim Schedules will be discussed. - RF-2A and Worksheets (Monthly Statement of Administrative Expenditures and Purchase of Expenditures for Federal and State Aid, DSS-1272-A, 1-2-3)
- RF-3 Adjustment Claim for Additional State Aid on Expenditures 100% Reimbursable, DSS-843)
- RF-6 (Monthly Claim for Reimbursement and Statistical Report Assistance to Resettled Refugees, DSS-1047)
- RF-9 (Computation and Claim for Additional State Reimbursement for Medical Assistance under Long Term Care, Presumptive Eligibility and HR Related Parents, DSS-3580)
