The purpose of this letter is to advise you of revised and final Foster Care Reimbursement Cap amounts for SFY 1994/95. The original chart, issued in 94 LCM-116, did not include FNP administrative costs. The attached revised Cap amounts continue to reflect a district's payment or non-payment of foster care cost-of-living adjustments (COLA).

Districts' foster care savings plans or waiver requests have been reviewed, and recommendations made to the NYS Division of the Budget. We will notify you when this process is completed, either approving a savings plan or a waiver exception.
