### PAYMENT PROCEDURES SUMMARY

There are two methods of payment for supplemental expenses:

1) The Local District or Voluntary Agency purchases services or products from the CONNECTIONS contractor and the Department pays for these upfront on behalf of the Local District/Voluntary Agency.

The Department recoups the Local District costs through a bottom line deduction to its monthly settlement claim.

The Department recoups the Voluntary Agency costs through a bottom line deduction to the monthly settlement claim of the Local District that sponsored the Voluntary Agency's request. The Local District is responsible for obtaining reimbursement from the Voluntary Agency.

#### The Department pays up-front for:

- site Surveys
- supplemental equipment purchased from the CONNECTIONS contractor. [The amount that will be eligible for reimbursement to the Local District through the normal administrative claiming process will be determined by the function(s) of the staff that receive and use the equipment. The appropriate cost allocation plan will apply.]
- network connectivity architect analysis
- site preparation completed by the CONNECTIONS contractor
- supplemental installation costs completed by the CONNECTIONS contractor
- additional bandwidth

### PAYMENT PROCEDURES SUMMARY

The Local District or Voluntary Agency purchases the services or products from it's own contractor (with prior approval from the Department). The Local District or Voluntary Agency pays for these directly.

The Local District is reimbursed through the normal administrative claim process.

The Voluntary Agency is reimbursed through the rate setting process.

### Local District/Voluntary Agency pays the costs directly for:

- site preparation costs (not completed by the CONNECTIONS contractor), including the provision of clear cabling paths (raceways, conduit, etc.)
- Department approved installations completed by a Local District or Voluntary Agency contractor.
- Department approved supplemental equipment (NOT purchased from the CONNECTIONS contractor)
- security and theft deterrents NOT purchased from the CONNECTIONS contractor
- furniture NOT purchased from the CONNECTIONS contractor
- monthly ongoing telecommunications charges (only those sites with 4 PCs or less)
- monthly maintenance NOT provided by the CONNECTIONS contractor
- liability insurance
