The purpose of this memorandum is to inform you of a statewide teleconference on prevention entitled, "Promoting School Success Through Community Partnerships" to be held on Thursday, April 17th. Several State agency commissioners, including Acting Commissioner Wing and John Johnson, Director of the Division for Youth will be participating in this teleconference which is sponsored by United Way of New York State, New York State Departments of Education and Health, New York State School Boards Association, and their partners. Its purpose is to highlight the importance of prevention, underscoring the relationship between child well-being and success in school, and promoting school/health/human services linkages as key to improvements in child well-being and success in school. Information on model collaborations from across the state will be presented.

This teleconference emanates from an agreement entered into by United Way of New York State and the New York State Board of Regents/State Education Department called "Partners for Children". The State Department of Health has indicated its desire to formally join the agreement in the near future. "Partners for Children" aims to ensure that all children are healthy and ready to learn and that those in schools are able to succeed. Critical to the success of the collaboration will be joint efforts to increase the availability of health and human services right in the schools to assist communities in improving outcomes for children.

Goals of the Partners for Children Agreement - Ensure Healthy Children, School Readiness and Success in School Through:

1. A statewide network of programs focused on prevention and early detection and treatment.
2. A commitment to long-term leadership and collaboration.
3. Partnerships among local stakeholders.
4. Providing beneficial services to children with disabilities in community and school settings.
5. Public awareness.

Critical Success Factors

1. Communities will be mobilized to support all children and their families.
2. Good health and protection, through the provision of appropriate and adequate health care services for children and adolescents, will be enhanced.
3. Responsible parenting will be supported and promoted.
4. Quality child care choices for young children will be expanded to enhance school readiness.
5. Services and supports to continue the "right start" achieved in early childhood will be provided, optimally within the school setting, to strengthen school achievement and success.
6. Linkages will be established with programs and supports to discourage adolescent participation in high risk activities, increase high school completion rates, and improve readiness for work and/or higher education.
7. To the extent possible, all children will receive the array of services and supports necessary to enhance educational achievement within the least restrictive setting.

Expectations of Local Partners for Children

Local collaboration activities will be determined by local stakeholders and should be based on agreement regarding assets, strengths, needs and priorities. Partners should seek to:

- o expand the group of local stakeholders involved in planning and development activities, to achieve a balanced mix of United Way, school, school board, county, business, service provider, labor, parent and funder interests;

- o identify local strengths, capacity and needs including indicators of child well-being, existing services, funding, gaps, and barriers;
- o prioritize local needs for children's services;
- o develop outcome measures to evaluate the effectiveness of local prevention and intervention activities, and performance targets that will measure progress;
- o develop strategies to implement locally determined school/health/human services collocation plans; and
- o increase local awareness and support for school/health/human services linkages.

Since collaboration among public and private stakeholders at the local level around the goals of this initiative is critical to meeting the needs of children served by the local social services system, your participation at the teleconference is encouraged. The teleconference is scheduled from 9:00am to 10:30am to be followed by one and one-half hour local forums providing local participants an opportunity to react to the information presented, begin an analysis of local assets and needs, and initiate discussions about possible follow-up steps.
