SUBJECT: SFY 1997/98 Family and Children's Services Funds Allocations

The purpose of this memorandum is to provide social services districts with their family and children's services funds allocations for State Fiscal Year (SFY) 1997/98 (April 1, 1997 through March 30, 1998) from these sources:

- (1) the SFY 1997/98 Family and Children's Services Block Grant (FCSBG) appropriation (\$507,335,000);
- (2) the transfer of funds from Temporary Assistance to Needy Families (TANF) to Title XX (\$98,400,000).

The Federal Title XX funds appropriation allocation will be made to districts in a separate memorandum.

The methodologies for the allocation of these funds are set out below and are the basis for the allocations tables which accompany this memorandum as Attachments.

Family and Children's Services Block Grant (FCSBG) Allocation

After first setting aside \$7.4 million to be used for the support of congregate foster care, 90% of the remaining \$499,935,000 FCSBG balance (\$449,941,500) has been allocated to districts based on district expenditures as adjusted by the State Random Moment Study (SRMS) for block

grant services (foster care, adoption services other than adoption subsidy, child protective services, and preventive services for children) in Federal Fiscal Years (FFY) 1994/95 and 1995/96. This allocation is determined by adding together whichever is the higher of the district's FFY 1994/95 or FFY 1995/96 claim for each of the four block grant services categories to get the district's FFY 1995/96 FCSBG base claim. The base claims for all districts were then totaled and each district's individual percentage share of the Statewide total was calculated. The district percentages thus calculated were used to compute the amount of each district's allocation for the 90% amount (\$449,941,500).

To this amount was then added the distribution of the \$7.4 million for the support of congregate foster care: \$6.4 million to New York City and \$1.0 million distributed to Upstate districts in the same proportion as each district's percentage share of the 90% amount as calculated above bears to the Upstate (other than New York City) total of the 90% amount.

Finally, the remaining amount of the FCSBG (\$49,993,500) has been allocated in the following order:

- (1) allocate funds so as to create allocation stabilization, that is, to ensure that each district's 1997/98 allocation is at least equal to the district's allocation for FFY 1996/97 prior to the addition of allocations based on the district's child population estimates and child protective services reports for Calendar Year 1995;
- (2) reserve \$9,167 for payment to Ulster County per subsection 153-d, SSL, stipulation;
- (3) create a \$500,000 fund for grants to offset extreme foster care expenditure rises in small districts of less than 16,000 total child population under the age of 18; and
- (4) distribute remaining funds to all districts based one-half on each district's percentage of child population estimates on a Statewide basis and one-half on each district's percentage of child protective reports on a Statewide basis for Calendar Year 1996.

Temporary Assistance to Needy Families (TANF) Title XX Transfer

In accordance with the enabling provisions of Federal law and regulations on TANF and Title XX, the State has chosen to transfer \$168,400,000 of TANF funds for the support of Title XX and child welfare services. Of this amount, \$20,000,000 has been allocated to districts pursuant to the Title XX allocation formula in which each district's share of the \$20 million allocation is based on the district's FFY 1995/96 Title XX allocation in proportion to the total Statewide FFY 1995/96 Title XX allocation.

Another \$78.4 million of the TANF transfer has been allocated based on the final allocation percentage determined in the FCSBG allocation outlined above. \$8.4 million of these funds are specifically being allocated to ensure the availability of funds for Title XX services in light of the congregate foster care set-aside being made from the basic FCSBG appropriation. The remaining \$70 million will be used to offset State funds.

Because of the Federal TANF income eligibility requirements, these funds must be expended for services to families whose income is no greater than 200% of the Federal Poverty Income level for the family size. All Title XX rules apply to these funds, including the prohibition for use for foster care maintenance.

Transfer Implementation

Chapter 436 of the Laws of 1997 renames the Department of Social Services as the Department of Family Assistance comprised of two independent offices: the Office of Children and Family Services and the Office of Temporary and Disability Assistance. Upon the execution of a Memorandum of Understanding and compliance with the Civil Service Laws, responsibility as specified in Chapter 436 will be transferred from the former Department of Social Services to the Office of Children and Family Services (OCFS) and fully integrated with the functions and duties of the former Division for Youth. The contents contained herein have been approved by all necessary staff of the referenced agencies.
