## I. Purpose

The purpose of this release is to notify local districts that the following form is obsolete:

PUB-1350: "How To Get Your Cash Grant and Food Stamps" (Rev.10/97)

### II. Background

With the advent of a Statewide Electronic Benefit Transfer (EBT) System in 1999 and the elimination of Food Stamp coupon issuance in March 2003, the informations and instruction contained in PUB-1350 are no longer valid.

## **III. Program Implications**

In all instances where the PUB-1350 was used, local districts must now use the PUB-4596: "Electronic Benefit Transfer (EBT) Brochure".

Effective immediately, the PUB-1350: "How To Get Your Cash Grant and Food Stamps" (Rev.10/97) is obsolete.

Any remaining supplies of this form should be destroyed.
