Section 2

I. Purpose

The purpose of this Informational Letter (INF) is to inform local districts that the <u>PUB-4596:</u> <u>EBT Training Brochure</u> has been revised.

II. Background

The publication 08 INF-11 informed local districts that PUB-4596: EBT Training Brochure was significantly changed in both content and format. This release is to advise local districts that due to a change in federal Food Stamp program rules, the EBT Brochure has been revised again effective October 2008.

III. Program Implications

The revision to the brochure is on page 8 in the Expunged Benefits section. On October 1, 2008, the new Food Stamp program expungement parameter was changed to 365 consecutive days, instead of the previous 270 consecutive days. This section has been changed to reflect the new federal policy. In addition, the revision date on the brochure cover has been changed to 10/08.

IV. Forms Ordering Information

- We expect that the printed version of the revised 10/08 PUB-4596: EBT Training Brochure, English on the front and Spanish on the reverse, should be printed and available for ordering in April 2009 (see Attachment for a sample). Once received, the revised 10/08 PUB-4596 should replace any copies of the previous version.
- In addition to the <u>English</u> and <u>Spanish</u> versions, the <u>Arabic</u>, <u>Chinese</u>, <u>French</u>, <u>Haitian-Creole</u>, <u>Korean</u>, <u>Russian</u>, <u>Vietnamese</u>, and <u>Yiddish</u> versions were also updated to reflect this revision. These versions are not printed but are available to local districts as camera-ready masters on the EBT page of OTDA's web site <u>www.otda.state.ny.us/main/ebt/publications.htm</u>. These translated versions can be reproduced locally.

Additionally, local district staff can download these versions from the LDSS E-forms site.
