I. Purpose

The purpose of this Informational Letter (INF) is to inform local districts that the following publication has been added to the LDSS-4148 series as a handout to the clients:

LDSS-4148D (10/09): "New Information About Temporary Assistance and Food Stamps".

II. Background

The LDSS-4148D is being introduced to reflect federally mandated changes that will be effective on or after October 1, 2009.

III. Program Implications

Effective October 1, 2009, local districts must provide the LDSS-4148D at application (LDSS-2921) and recertification (LDSS-3174) of Temporary Assistance/ Food Stamp benefits, along with the LDSS-4148A, B, and C. For Non-Temporary Assistance Food Stamp households receiving the LDSS 4826A ("How to Complete the Food Stamp Benefits Application/Recertification and Applicant/Recipient Rights and Responsibilities for the Food Stamp Program") at application and recertification, the LDSS-4148D must be provided as well.

IV. Forms Ordering Information

- The English version of the LDSS-4148D: "New Information About Temporary Assistance and Food Stamps" and LDSS-4148D-SP (Spanish) are State printed forms. Initial supplies of the English forms have been drop-shipped to local districts. Please see ordering instructions, below, for obtaining a supply of the LDSS-4148D-SP (Spanish) forms.
- The "other than English/Spanish" versions of the LDSS-4148D: "New Information About Temporary Assistance and Food Stamps" [LDSS-4148D-AR (Arabic), LDSS-4148D-CH (Chinese), LDSS-4148D-FR (French), LDSS-4148D-HA (Haitian-Creole), LDSS-4148D-KO (Korean), LDSS-4148D-RU (Russian), LDSS-4148D-VI (Vietnamese) and LDSS-4148D-YI (Yiddish)] are **not** State printed but are available to local districts in PDF format or as master camera ready copies. The procedures for ordering PDFs or master camera ready copies are listed below.
