Section 2

I. Purpose

The purpose of this Local Commissioners Memorandum (LCM) is to inform social services districts (districts) that the New York State (NYS) Office of Temporary and Disability Assistance (OTDA) has developed an insert for the client information book, <u>LDSS-4148B</u>: "Book 2: What You Should Know About Social Services Programs."

II. Background

In accordance with <u>90 ADM-41</u>: "New Client Informational Books," the client information books ("the Books") <u>LDSS-4148A</u>: "Book 1: What You Should Know About Your Rights and Responsibilities," <u>LDSS-4148B</u>: "Book 2: What You Should Know About Social Services Programs," and <u>LDSS-4148C</u>: "Book 3: What You Should Know If You Have an Emergency" were first published and mandated in 1990. The Books are designed to provide information to applicants and recipients in a printed form. These Books became available online in December 2017.

The Books provide information regarding program requirements and answers to questions that applicants and recipients may have about social services benefits, including Temporary Assistance (TA), the Home Energy Assistance Program (HEAP), the Supplemental Nutrition Assistance Program (SNAP) and Medical Assistance (MA). The Books also provide information on other services including adoption, child care, child support, child welfare, foster care, and other available programs.

III. Program Implications

Pending revisions to the LDSS-4148B, the LDSS-4148B.1 Book 2 Insert (see Attachment) was created to provide applicants and recipients of TA with up-to-date information on current OTDA non-citizen¹ eligibility policy. It is important to note that this LCM is not instituting any policy changes in this area. The Book 2 Insert replaces the first Question and Answer (Q & A) on page 6 of the LDSS-4148B. Non-citizen eligibility information contained within the policy documents listed below are included in the Book 2 Insert.

Districts must provide the Book 2 Insert when providing printed copies and/or using the online delivery method of the Books to applicants and recipients. 17-ADM-10: "Online Distribution of Client Information Books LDSS-4148A, LDSS-4148B & LDSS-4148C" contains further guidance regarding the online distribution method for the Books. The Book 2 Insert must be provided until the revised version of the LDSS-4148B is finalized and available for districts to distribute. Additionally, the Book 2 Insert is available in each of the required language translations and alternative formats.

IV. Forms Ordering Information

In November 2021, districts will receive shipments of the English and Spanish versions of the Book 2 Insert. If a district does not receive their initial shipment by November 30, 2021, they should contact OTDA document services by emailing: forms.orders@otda.ny.gov. Once received, districts must immediately begin to provide the Book 2 Insert, either in print form or using the online distribution option, when providing printed copies and/or using the online delivery method of the Books to applicants and recipients. When applicants and recipients wish to access the Books and the Book 2 Insert online, the documents can be found on the OTDA website at: http://otda.ny.gov/ under "Forms." The Book 2 Insert may be downloaded by districts for reproduction locally from the OTDA intranet site at: http://otda.state.nyenet/ldss_eforms/ and from the OTDA public-facing website at: http://otda.ny.gov/programs/applications/. The Book 2 Insert is available on the aforementioned websites in English and in the languages and alternative formats included in the Translated Versions and Alternative Formats paragraphs below.

Beginning December 01, 2021, additional stock of the English and Spanish versions of the Book 2 Insert, in both alternative and non-alternative formats, may be ordered by submitting a completed OTDA-876 form, available at: http://otda.state.nyenet/ldss_eforms/, via email to: forms.orders@otda.ny.gov. ¹ As used in this LCM, the term "non-citizen" means a person who is not a citizen or national of the United States (U.S.). The term "qualified non-citizen" means a person who is a "qualified alien" as that term is defined in 8 U.S.C. §1641. ŎTDA 21-LCM-22 (Rev. 11/2021)

Translated Versions

Currently, Book 2 is available in Arabic, Chinese (traditional), Haitian Creole, Italian, Korean, Russian, and Spanish. These languages are represented among the most common non-English languages spoken by individuals with limited English proficiency in NYS, based on the most recent census data. Translated versions of the Book 2 Insert in the previously referenced languages can be downloaded from the OTDA intranet site at: <u>http://otda.state.nyenet/ldss_eforms/</u> and from the OTDA public-facing website at: <u>http://otda.ny.gov/programs/applications/</u>. Additional translations in Bengali, Polish and Yiddish will also be available at a future date. Paper copies of the Spanish version of the Book 2 Insert can also be ordered from OTDA, per the instructions above.
