Section 2

I. Purpose

The purpose of this informational letter is to introduce a new form, LDSS-5260 Telephonic Administrative Disqualification Hearing Cover Letter Form (**Attachment 1**), designed for use by local district staff to send to applicants/recipients in order to confirm a current and correct phone number prior to a scheduled telephonic administrative disqualification hearing (ADH).

II. Background

Due to an increased volume in telephonic ADHs in recent years, there has been a greater need to confirm current and correct phone numbers for applicants/recipients prior to the scheduled hearings. With the recent release of 23DC083 - Demonstration Project – Administrative Disqualification Hearings for Intentional Program Violations, social services districts will continue to conduct ADHs through various means of communication, including telephonically. It is imperative that the Administrative Law Judge has the correct phone number to conduct the hearing.

III. Program Implications

Use of the LDSS-5260 "Telephonic Administrative Disqualification Hearing Cover Letter" Form attached to this informational letter is optional but recommended. Districts may find it to be useful to include with the evidentiary packet sent to the client prior to the telephonic ADH. The new form is also posted on the intranet page for LDSS e-forms.
