The purpose of this GIS is to instruct local districts affected by Hurricane Sandy to accept requests for replacement of SNAP benefits until November 28, 2012. Clients now have until December 10, 2012 to file a signed and completed LDSS-2291 or LDSS-2291A "Request for Replacement of Food Purchased with Supplemental Nutrition Assistance Program Benefits" form.

**Reporting/Filing Extension**

Under normal request for SNAP replacement rules, a household experiencing a loss of food due to a disaster must return a signed and completed "Request for Replacement of Food Purchased with Supplemental Nutrition Assistance Program Benefits" form within 10 days of the date of the report of loss.

Due to the extraordinary circumstances created by Hurricane Sandy, USDA today granted all states affected by Sandy a 20-day extension to the normal 10-day period for reporting loss of food due to disaster. Accordingly, households experiencing a loss of food due to Hurricane Sandy need to notify their local district of the food loss by November 28, 2012, and households have until December 10, 2012 to file the request for replacement form with the local district.

**Request for Replacement Form**

The "Request for Replacement of Food Purchased with Supplemental Nutrition Assistance Program Benefits" form (LDSS-2291, Rev 08/12) may be found at this link:
