The timeframe during which hot foods and food products prepared for immediate consumption will be considered "eligible foods" for purposes of the Supplemental Nutrition Assistance Program (SNAP), as long as they are purchased in retail food stores authorized by the Food and Nutrition Service, U.S. Department of Agriculture, for the following counties: Bronx, Kings, Richmond, Queens, New York, Nassau and Suffolk has been extended until February 28, 2013.

We ask that SSDs assist in informing SNAP clients in these counties that they are able to use their Electronic Benefits Transfer (EBT) card and SNAP benefits to purchase hot foods and prepared food items at authorized SNAP retailers through February 28, 2013.

Please see the attached notice that the U.S. Department of Agriculture has distributed to retailers to inform them about this extension.

The previous extension for Rockland, Westchester, Orange, Putnam and Sullivan counties remains in effect through January 31, 2013.

SPECIAL DISASTER RULES FOR ACCEPTING SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) EBT BENEFITS FOR HOT FOOD PURCHASES

Partial Extension

Due to Hurricane Sandy, and effective immediately, **retail food stores licensed by the Food and Nutrition Service to accept SNAP benefits in the following counties may accept SNAP benefits in exchange for HOT foods and foods intended to be consumed on retailer premises**:

> Bronx, Brooklyn (Kings), Manhattan, Queens, Staten Island (Richmond), Nassau and Suffolk

> > These special rules are in effect through

February 28, 2013

When hot foods in the above counties are purchased with SNAP EBT benefits through <u>February 28, 2013</u>, the purchases are NOT subject to sales tax, as the foods mentioned above are considered SNAP eligible during this period. **NOTE: The previous extension for Rockland, Westchester, Orange, Putnam and Sullivan Counties remains in effect only through January 31, 2013**.

We encourage you to continue posting special notice in the store letting SNAP customers know that they can use their SNAP EBT benefits to purchase hot foods and, where practical, may remain on the premises to consume those foods.
