## Section 2

The purpose of this General Information System (GIS) message is to provide social service districts (districts) with instructions on completing outreach for the 2020-2021 Home Energy Assistance Program (HEAP) Heating Equipment Clean and Tune benefit.

Districts must implement the Heating Equipment Clean and Tune benefit as outlined in <u>20-LCM-11</u>. Program requirements and eligibility criteria for the HEAP Heating Equipment Clean and Tune benefit must be met by qualifying applicants to receive a Heating Equipment Clean and Tune benefit and service.

The Office of Temporary and Disability Assistance (OTDA) has identified the Clean and Tune benefit outreach target population to be HEAP households that received a Heating Equipment Repair or Replacement (HERR) or Clean and Tune benefit during the 2019-2020 season, or households who received three emergency bill assistance benefits during the 2019-2020 season.

To assist districts with conducting outreach to this target population, OTDA has developed the following tools:

• Attachment 1 – "No Cost Clean and Tune flyer (PUB-5157)" – The No Cost Clean and Tune flyer is double sided and features English on one side and Spanish on the reverse.

- A district specific spreadsheet indicating recipients of HERR, Clean and Tune, or three emergency bill assistance benefits during the 2019-2020 program year that will be sent to districts under separate cover. The HEAP Bureau requests that districts inform clients identified on this spreadsheet of the availability of the 2020-2021 Heating Equipment Clean and Tune benefit.

The spreadsheet will contain recipient households who received a benefit with one of the following pay types during the 2019-2020 season:

- H5 (HEAP Emergency Benefit-Repair Heating Equip.)
- H7 (HEAP Emergency Benefit-Replace Heating Equip.)
- J1 (HEAP Emergency Benefit-Additional Benefit)
- J3 (Clean & Tune) during the 2019-2020 HEAP season.
