The purpose of this General Information System (GIS) message is to inform social service districts (districts) that the PUB-5118: "Work Pays Infographic" and PUB-5120: "Working and Your Benefits" have been revised to reflect the updated rate for the Standard Earned Income Disregard, effective June 1, 2024. These publications are designed to support the promotion of work and financial stability for low-income households, particularly working families.

New for this release, information was added to PUB-5120: "Working and Your Benefits" regarding the one-time six-month 100% Earned Income Disregard for Temporary Assistance (TA) recipients who start new employment.

These publications provide districts with a tool to help illustrate the advantages of employment and explain the impact of job entry on a TA household's benefits and eligibility.

These publications are intended to be used by stakeholders who interact and work with low-income households, such as districts, Career Center partners, other government agencies,

community-based organizations (CBOs), employers, and employer associations. Districts are strongly encouraged to share this resource with their local partners as appropriate.
