Temporary and Disability Assistance Statistics

SEPTEMBER 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 599,547 in September 2005, decreasing by 3,581 (-0.6%) from the previous month. Related expenditures totaled \$150,070,304 in September 2005 decreasing approximately \$6.5 million (-4.1%) over August 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,757,539 in September 2005, increasing by 13,454 (+0.8%) over August 2005. Food Stamps expenditures totaled \$181,908,385 in September 2005, increasing \$908,043 (+0.5%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For September 2005, SSI recipients (including Mental Hygiene) totaled 632,920 decreasing 5,447 (-0.9%) from the previous month. SSI expenditures in September totaled \$298,496,739 decreasing approximately \$19 million (-6.0%) from August 2005.

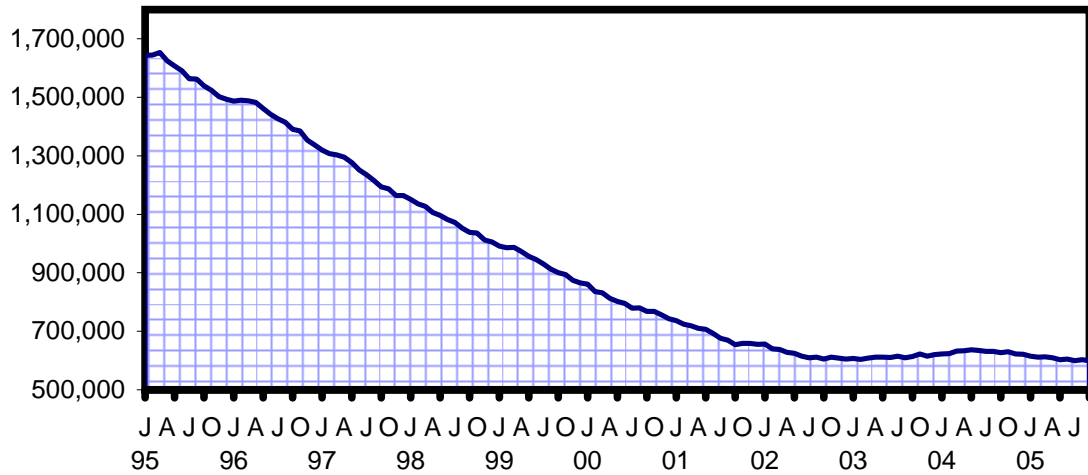

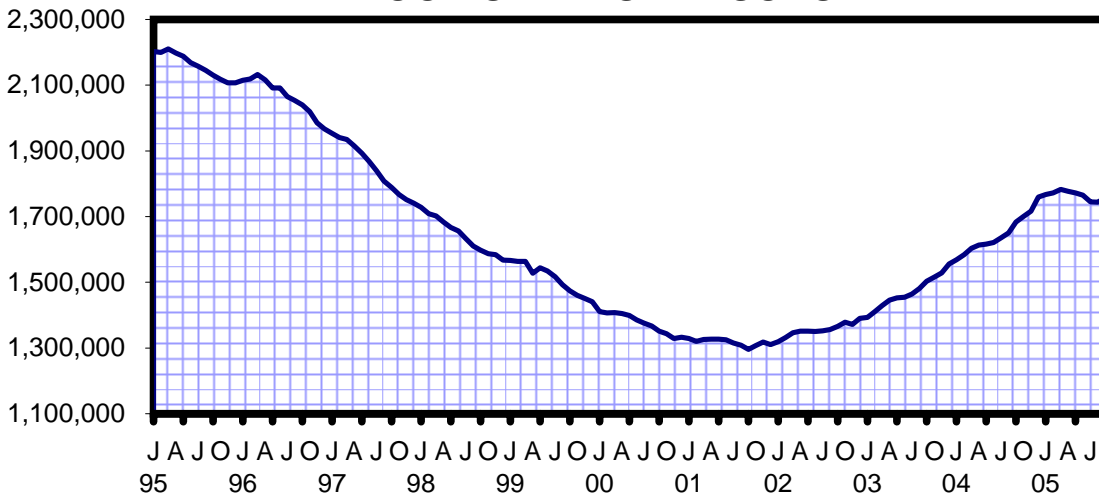

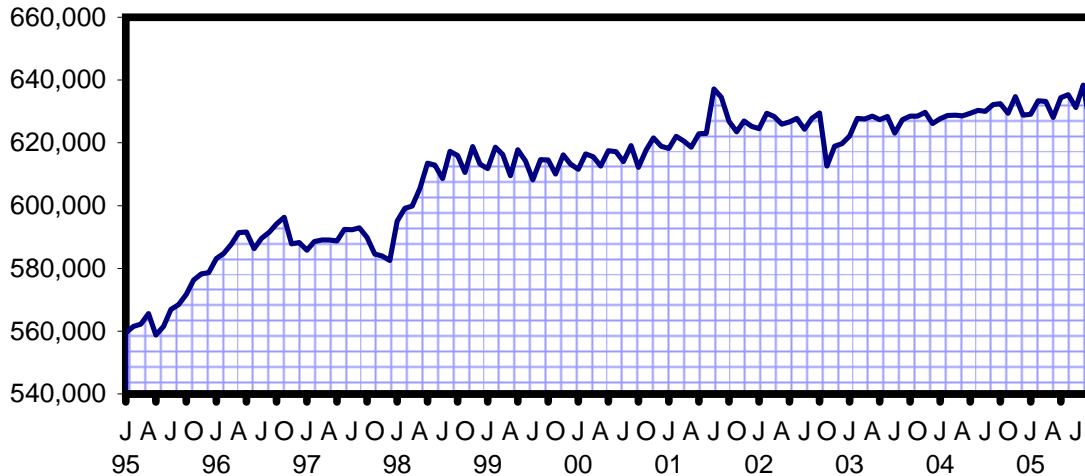
TEMPORARY ASSISTANCE RECIPIENTS
