Temporary and Disability Assistance Statistics JANUARY 2006

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 595,187 in January 2006, decreasing by 4,568 (-0.8%) from the previous month. Related expenditures totaled \$157,853,410 in January 2006 decreasing by approximately \$2.8 million (-1.8%) over December 2005.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,791,168 in January 2006, increasing by 1,017 (+0.1%) over December 2005. Food Stamps expenditures totaled \$185,683,470 in January 2006, decreasing approximately \$3.9 million (-2.1%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For January 2006, SSI recipients (including Mental Hygiene) totaled 637,748 increasing 359 (+0.1%) from the previous month. SSI expenditures in January totaled \$322,547,696 increasing approximately \$11.9 million (+3.8%) from December 2005.

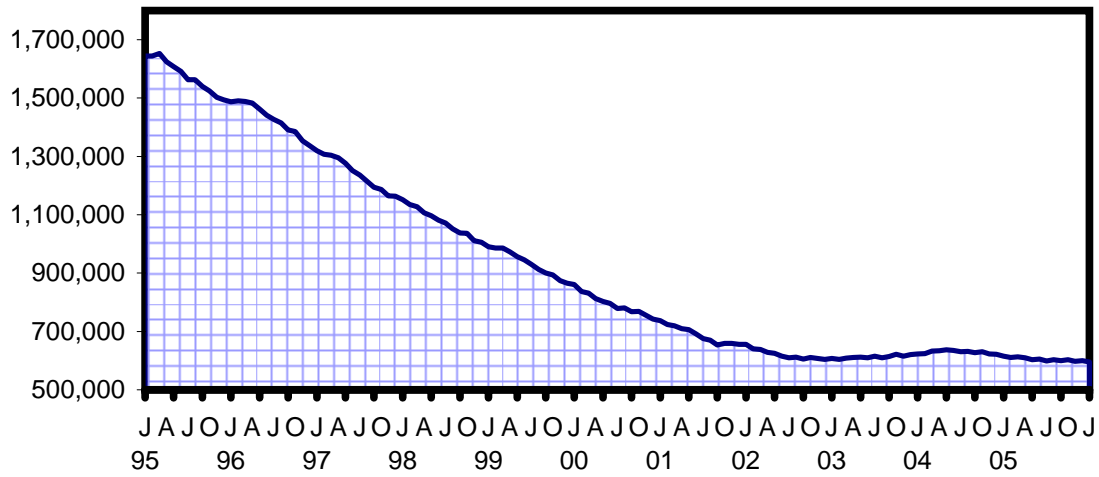

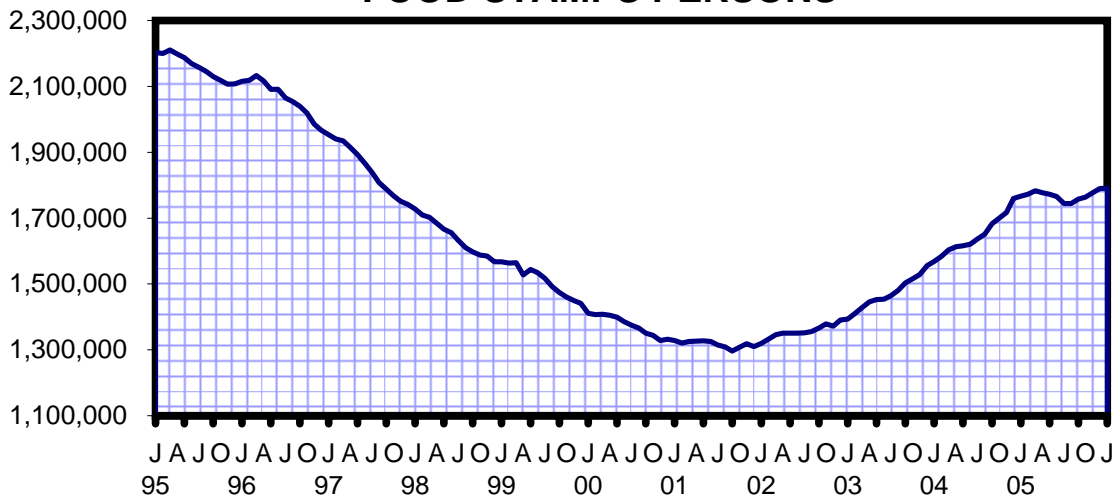

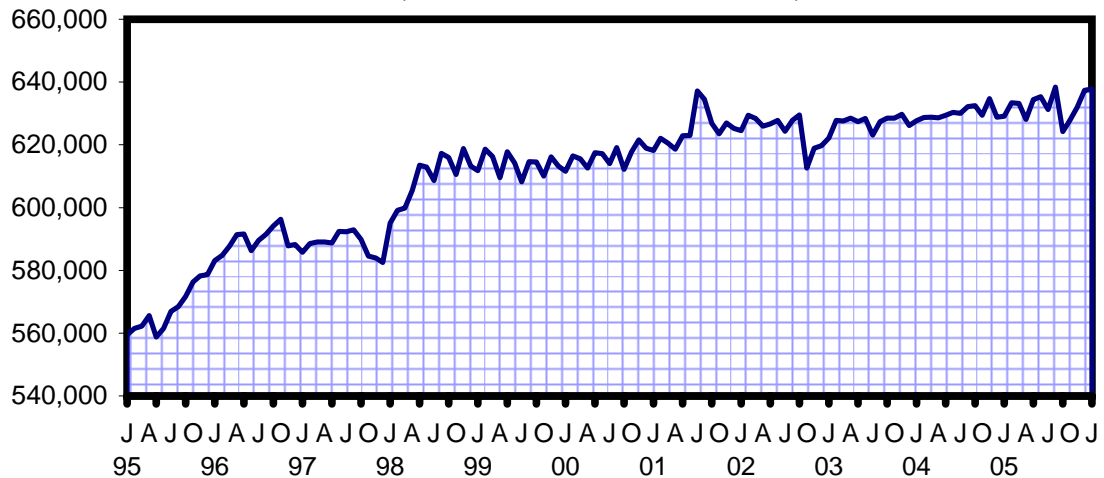
TEMPORARY ASSISTANCE RECIPIENTS
