Temporary and Disability Assistance Statistics July 2006

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 566,263 in July 2006, decreasing by 8,064 (-1.4%) from the previous month. Related expenditures totaled \$149,319,906 in July 2006, decreasing by approximately \$7.5 million (-4.8%) over June 2006.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,784,595 in July 2006, decreasing by 7,130 (-0.4%) over June 2006. Food Stamps expenditures totaled \$187,378,244 in July 2006, decreasing by \$306,798 (-0.2%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For July 2006, SSI recipients (including Mental Hygiene) totaled 642,147 decreasing 2,465 (-0.4%) from the previous month. SSI expenditures in July 2006 totaled \$319,569,072, decreasing by approximately \$3.1 million (-0.9%) from June 2006.

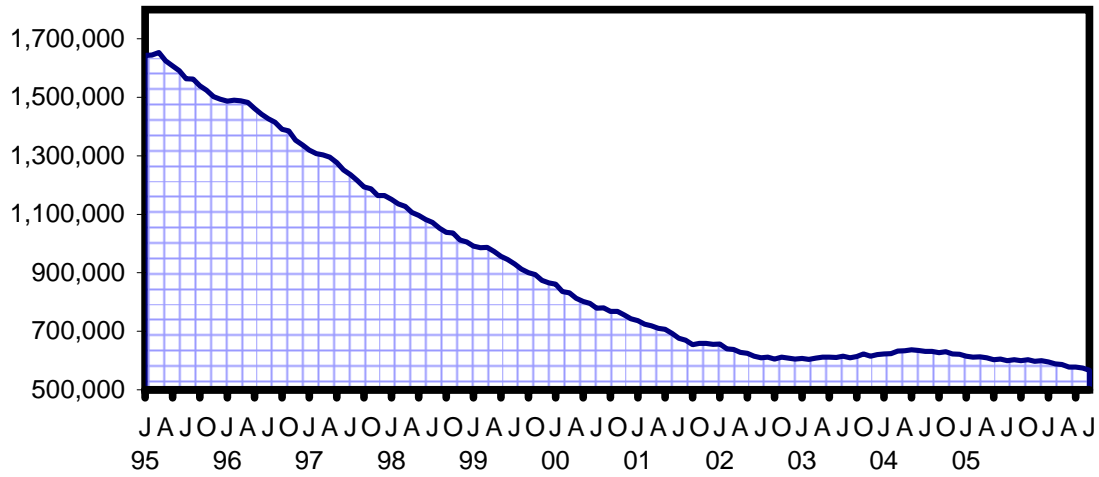

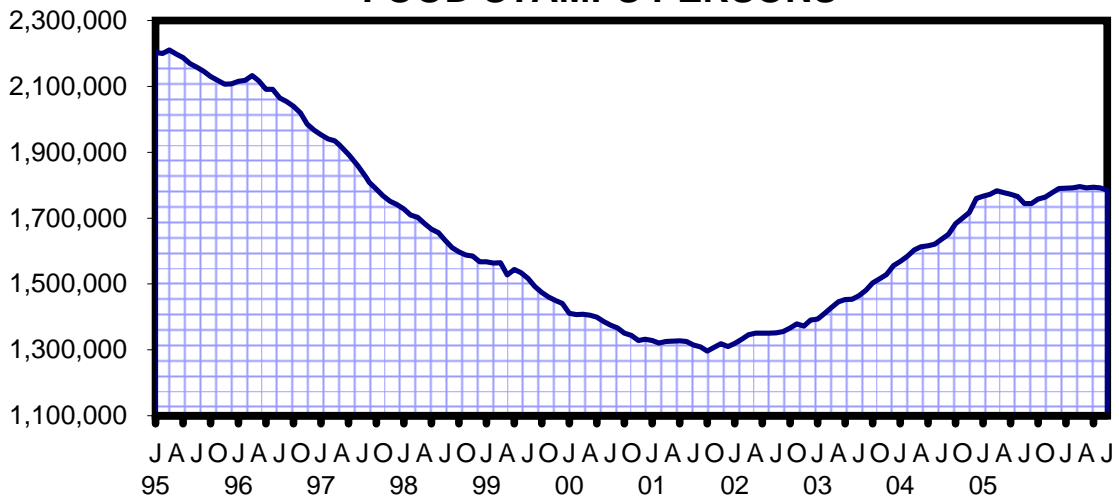

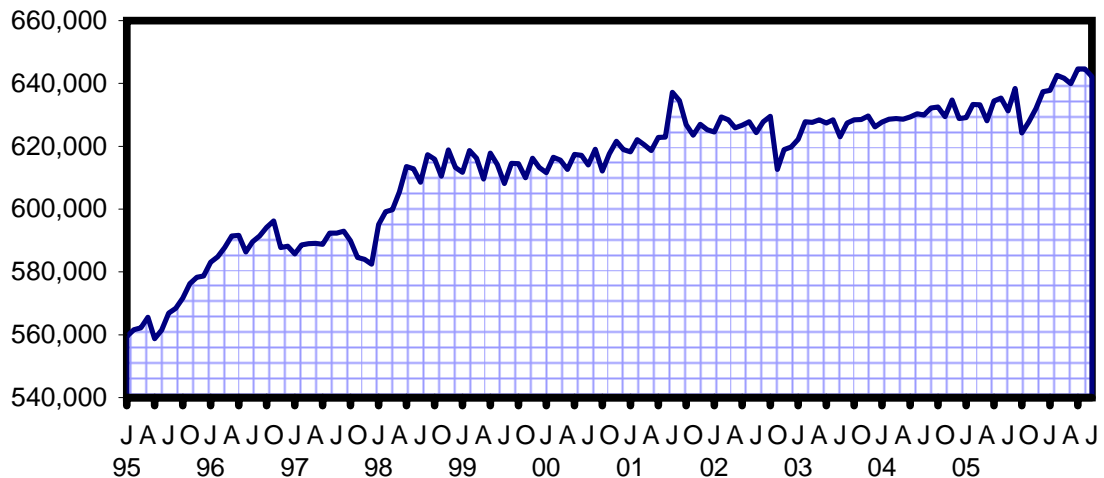
TEMPORARY ASSISTANCE RECIPIENTS
