APRIL 2007

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 535,447 in April 2007, decreasing by 7,059 (-1.3%) from the previous month. Related expenditures totaled \$150,334,259 in April 2007 decreasing by approximately \$3.5 million (-2.2%) over March 2007.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,805,436 in April 2007, decreasing by 4,658 (-0.3%) over March 2007. Food Stamps expenditures totaled \$192,813,089 in April 2007, decreasing approximately \$2.8 million (-1.4%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For April 2007, SSI recipients (including Mental Hygiene) totaled 646,034 decreasing 1,695 (-0.3%) from the previous month. SSI expenditures in April totaled \$337,804,931 increasing by \$813,094 (+0.2%) from March 2007.

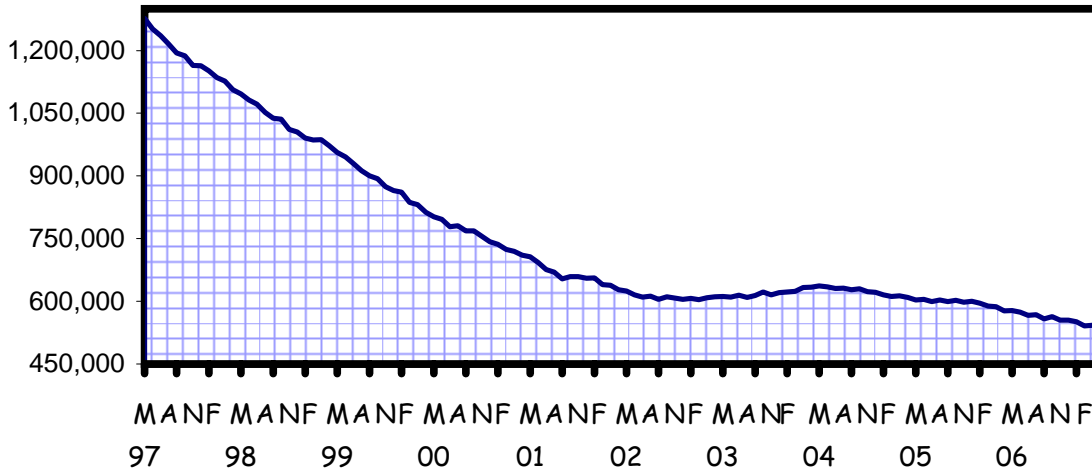

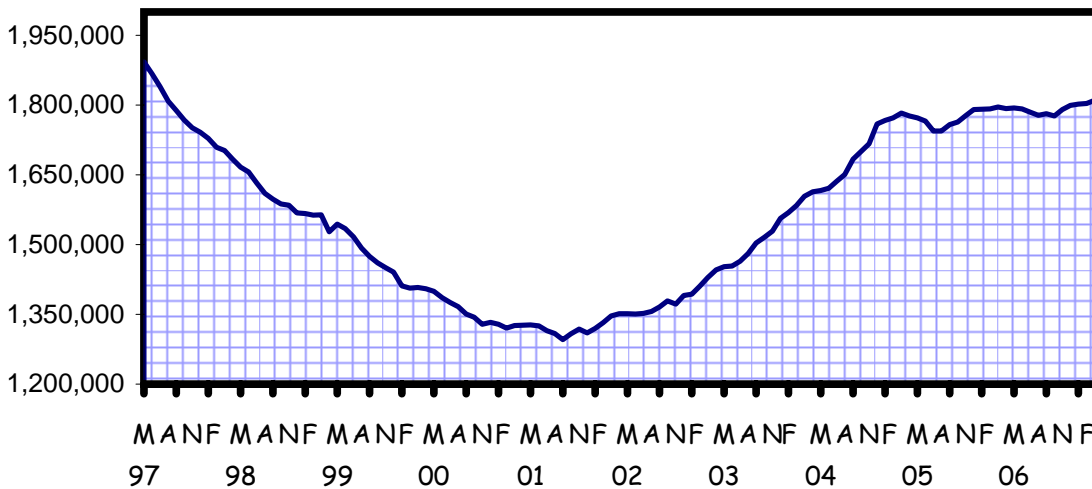

TEMPORARY ASSISTANCE RECIPIENTS**

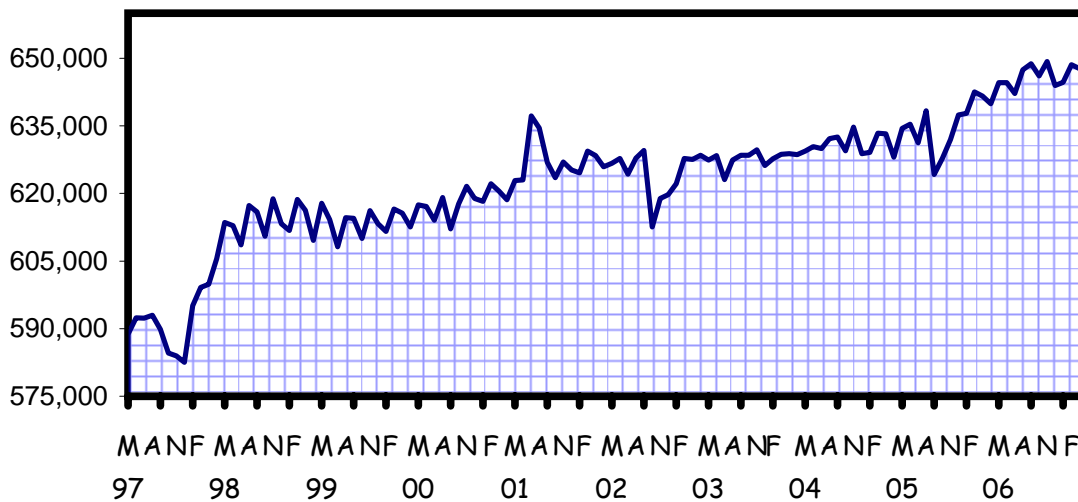


FOOD STAMPS PERSONS
