# Temporary and Disability Assistance Statistics

## MAY 2007

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 537,080 in May 2007, increasing by 1,633 (+0.3%) from the previous month. Related expenditures totaled \$152,831,910 in May 2007 increasing by approximately \$2.5 million (+1.7%) over April 2007.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,801,853 in May 2007, decreasing by 3,583 (-0.2%) over April 2007. Food Stamps expenditures totaled \$194,253,200 in May 2007, increasing approximately \$1.4 million (+0.7%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For May 2007, SSI recipients (including Mental Hygiene) totaled 649,860 increasing 3,826 (+0.6%) from the previous month. SSI expenditures in May totaled \$338,587,293 increasing by \$782,362 (+0.2%) from April 2007.

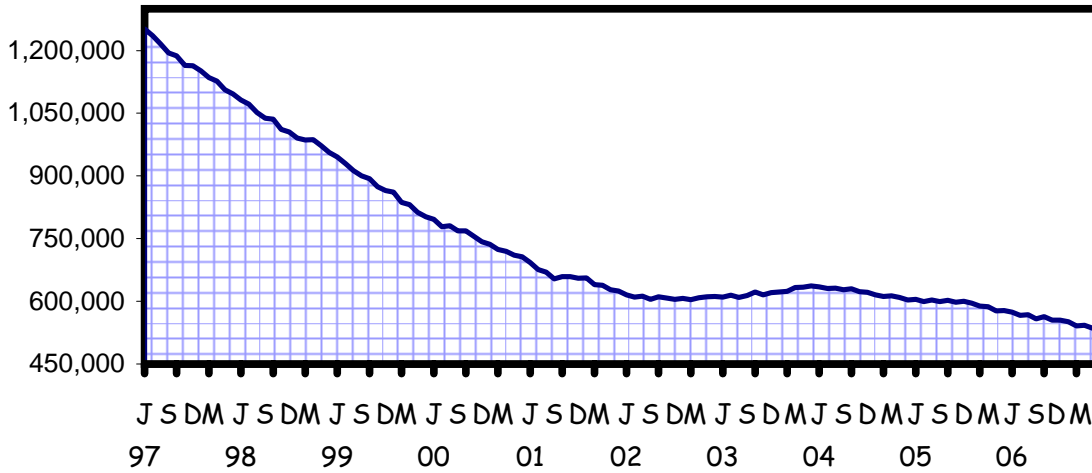

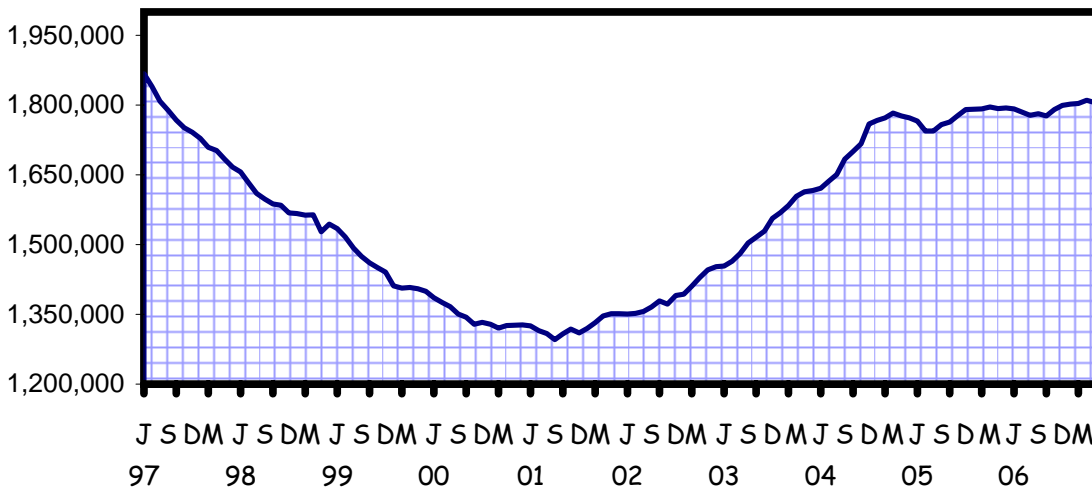

TEMPORARY ASSISTANCE RECIPIENTS**

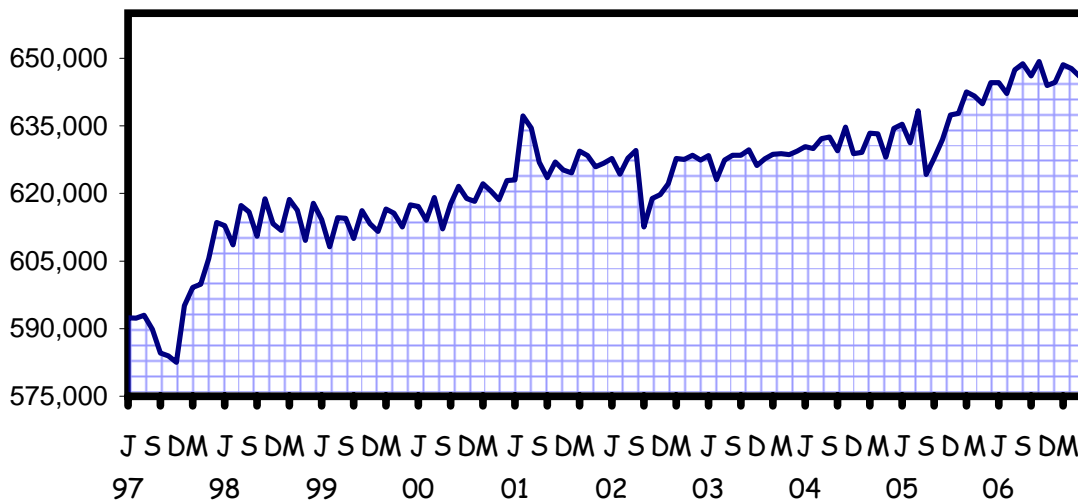


**FOOD STAMPS PERSONS**
