# Temporary and Disability Assistance Statistics

## SEPTEMBER 2008

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 501,049 in September 2008, decreasing by 2,578 (-0.5%) from the previous month. Related expenditures totaled \$157,007,470 in September 2008, increasing by approximately \$2.2 million (+1.4%) over August 2008.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,077,774 in September 2008, increasing by 26,163 (+1.3%) over August 2008. Food Stamps expenditures totaled \$227,561,003 in September 2008, increasing by approximately \$3.7 million (+1.7%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For September 2008, SSI recipients (including Mental Hygiene) totaled 661,166 increasing by 2,564 (+0.4%) from the previous month. SSI expenditures in September 2008, totaled \$356,533,112 increasing by approximately \$3.6 million (+1.0%) from August 2008.

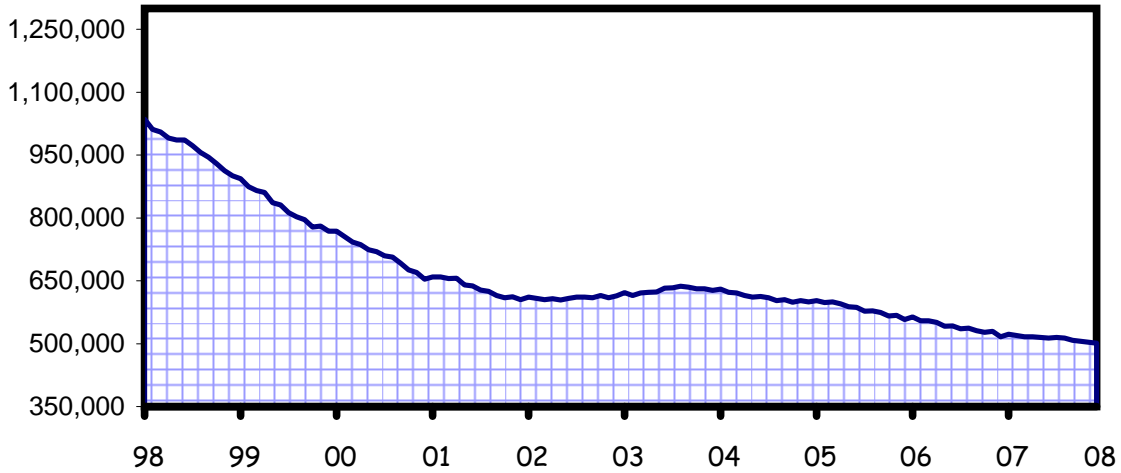

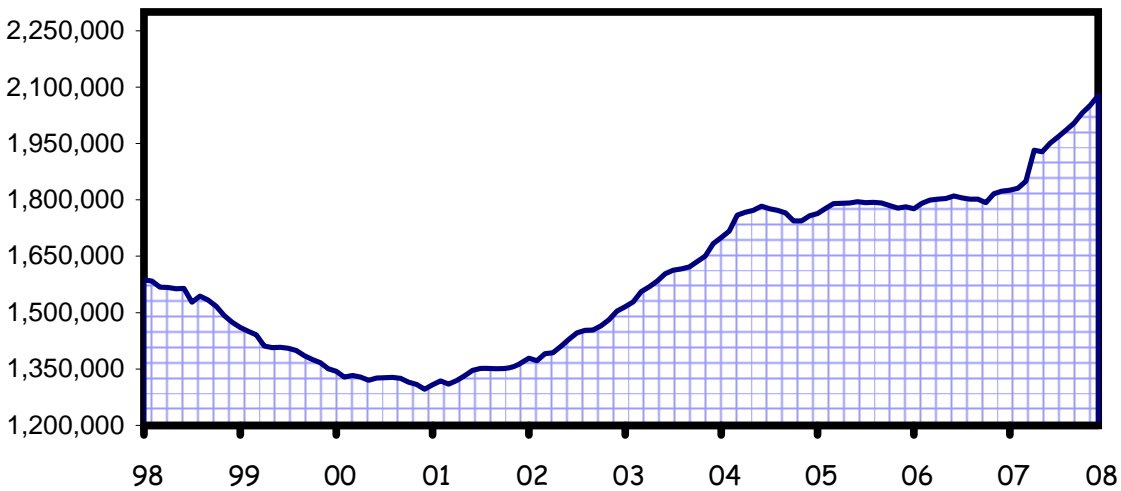

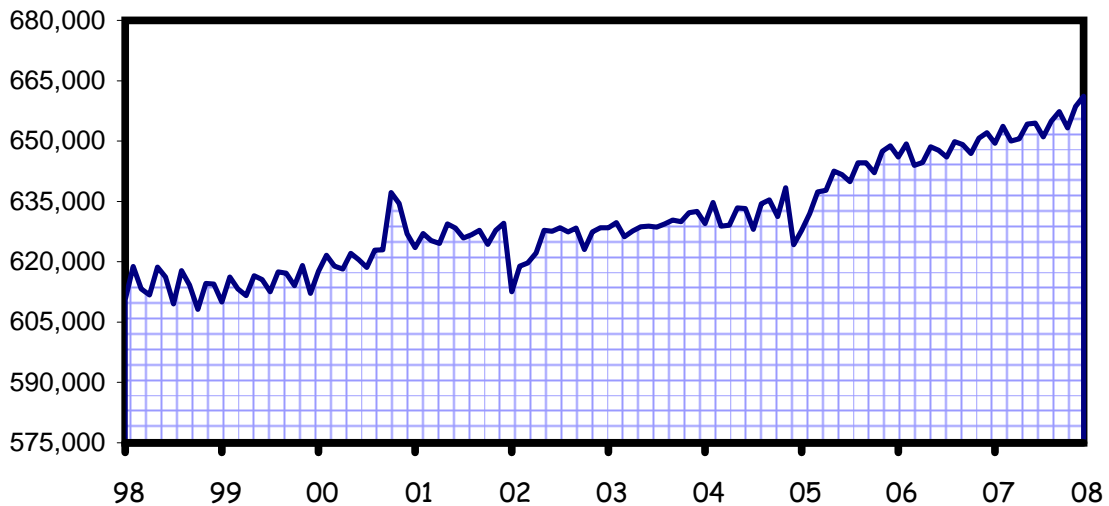
