MARCH 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 520,142 in March 2009, increasing by 3,302 (+0.6%) from the previous month. Related expenditures totaled \$163,765,389 in March 2009, increasing by approximately \$2.6 million (+1.6%) over February 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,295,103 in March 2009, increasing by 48,439 (+2.2 %) over February 2009. Food Stamps expenditures totaled \$307,568,883 in March 2009, increasing by approximately \$7.6 million (+2.5%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For March 2009, SSI recipients (including Mental Hygiene) totaled 665,791 increasing by 1,239 (+0.2%) from the previous month. SSI expenditures in March 2009, totaled \$376,823,030 increasing by \$519,045 (+0.1%) from February 2009.

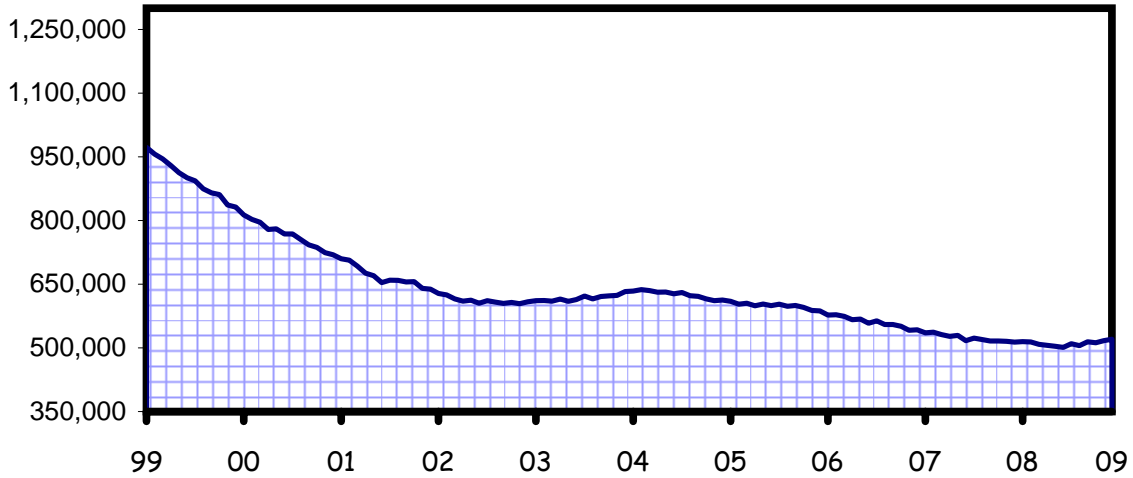

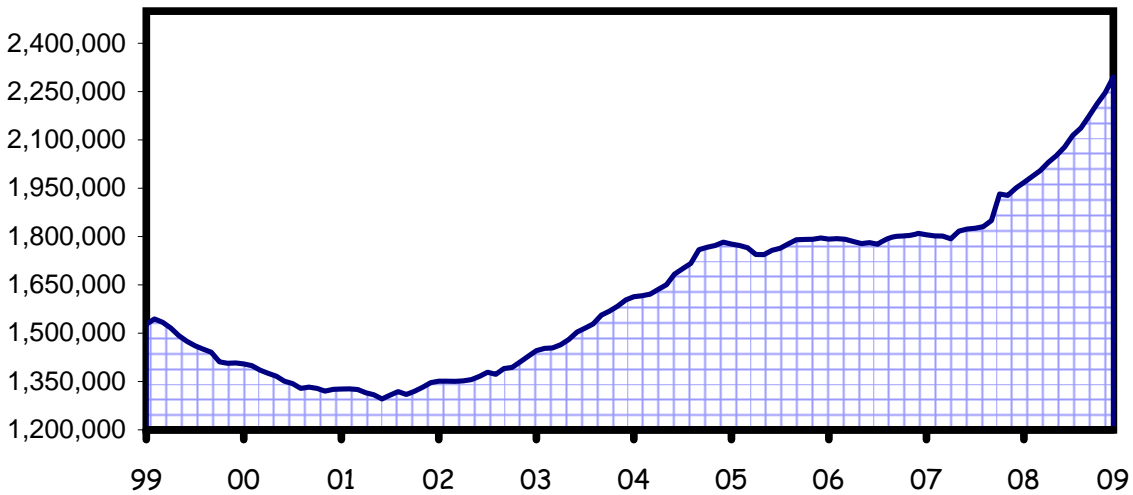

NEW YORK STATE APRIL 1999 - MARCH 2009 TEN YEAR TREND

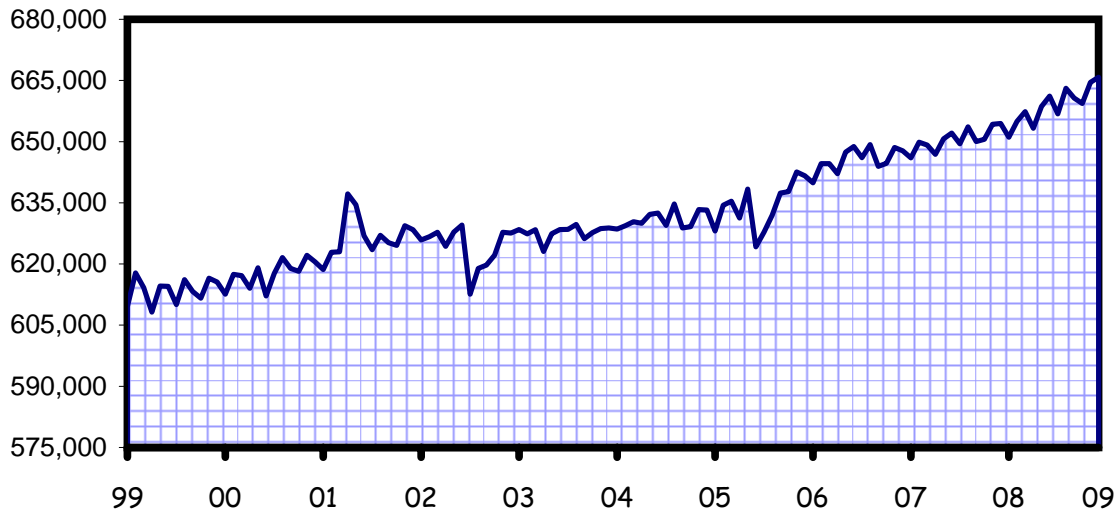
TEMPORARY ASSISTANCE RECIPIENTS
