MAY 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 521,088 in May 2009, increasing by 479 (+0.1%) from the previous month. Related expenditures totaled \$160,729,841 in May 2009, decreasing by approximately \$3.7 million (-2.3%) over April 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,384,027 in May 2009, increasing by 44,909 (+1.9 %) over April 2009. Food Stamps expenditures totaled \$366,510,921 in May 2009, increasing by approximately \$7.0 million (+1.9%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For May 2009, SSI recipients (including Mental Hygiene) totaled 666,790 increasing by 5,048 (+0.8%) from the previous month. SSI expenditures in May 2009, totaled \$377,404,610 increasing by approximately \$4.9 million (+1.3%) from April 2009.

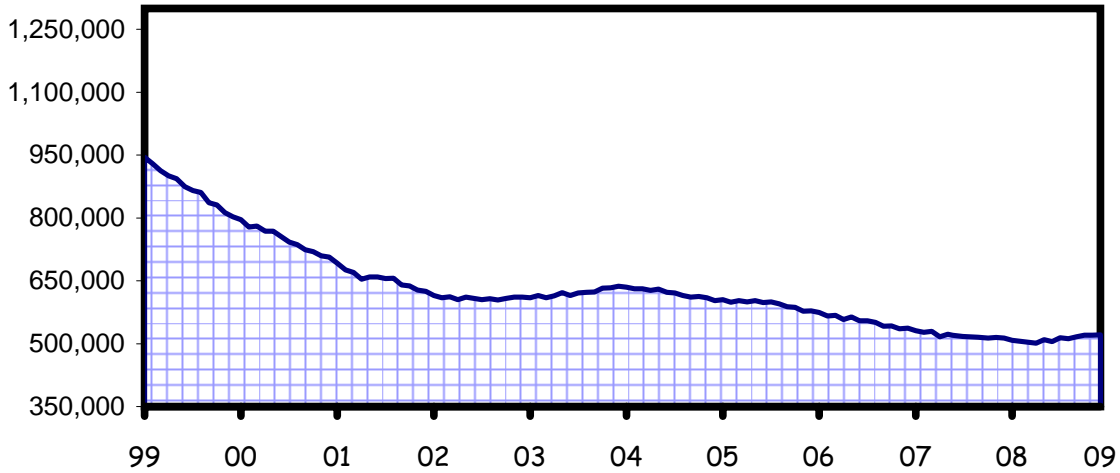

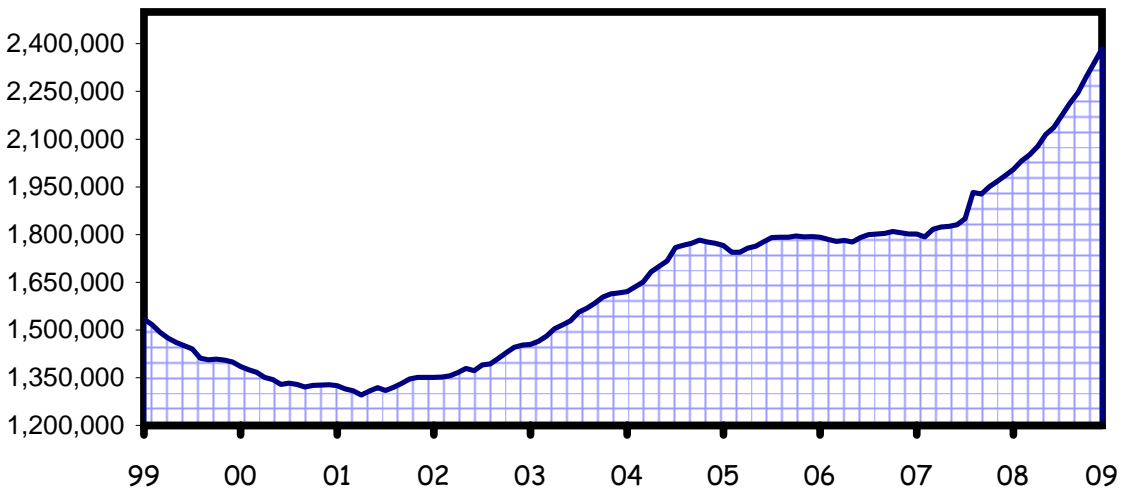

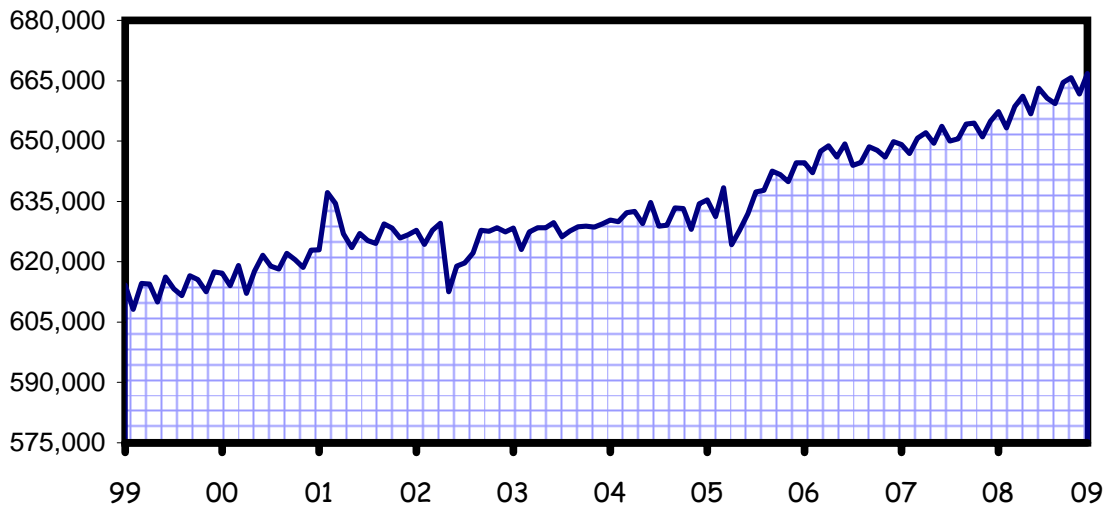
