Temporary and Disability Assistance Statistics

JULY 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 527,597 in July 2009, increasing 1,154 (+0.2%) from the previous month. Related expenditures totaled \$168,859,516 in July 2009, increasing by approximately \$4.9 million (+3.0%) over June 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,478,604 in July 2009, increasing by 50,763 (+2.1%) over June 2009. Food Stamps expenditures totaled \$378,614,146 in July 2009, increasing by approximately \$6.4 million (+1.7%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For July 2009, SSI recipients (including Mental Hygiene) totaled 663,841 decreasing by 5,408 (-0.8%) from the previous month. SSI expenditures in July 2009, totaled \$370,575,547 decreasing by approximately \$11.5 million (-3.0%) from June 2009.

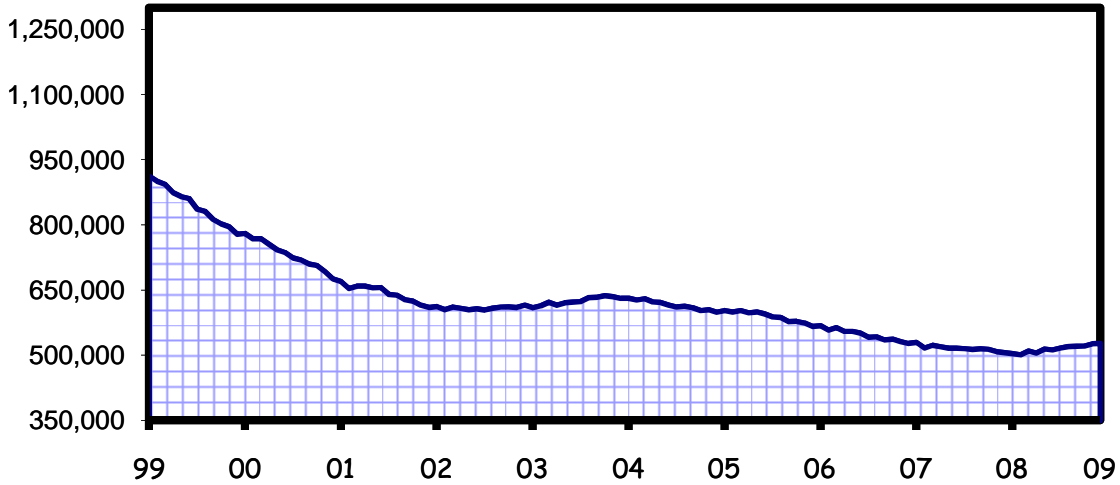

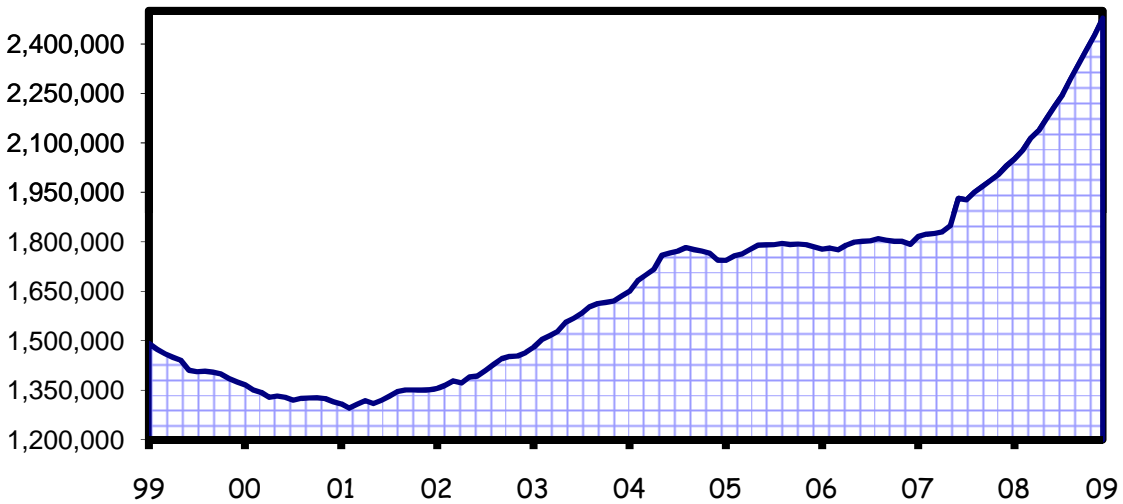

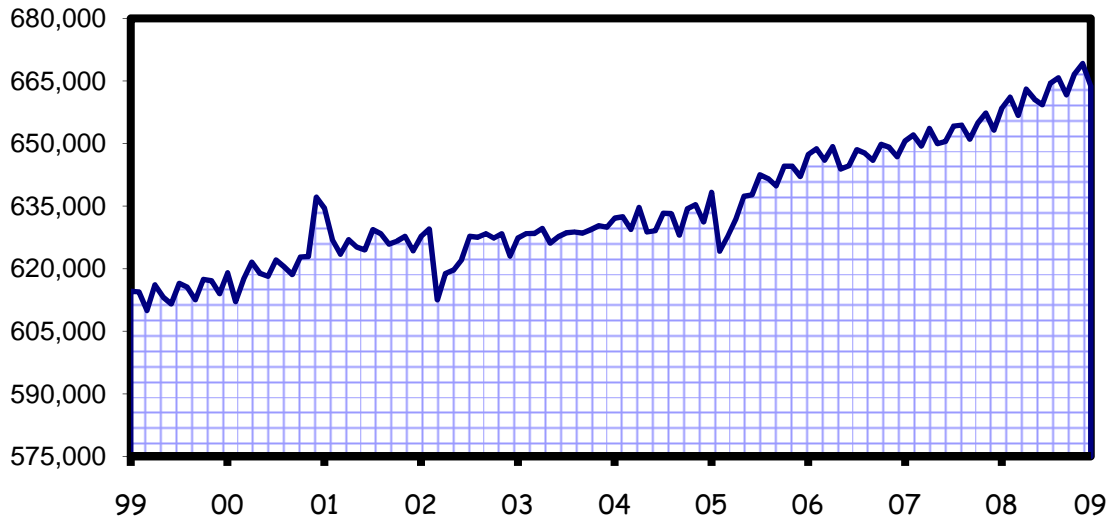
