Temporary and Disability Assistance Statistics **AUGUST 2009**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 530,663 in August 2009, increasing 3,066 (+0.6%) from the previous month. Related expenditures totaled \$165,449,750 in August 2009, decreasing by approximately \$3.4 million (-2.0%) over July 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,508,884 in August 2009, increasing by 30,280 (+1.2%) over July 2009. Food Stamps expenditures totaled \$383,773,369 in August 2009, increasing by approximately \$5.2 million (+1.4%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For August 2009, SSI recipients (including Mental Hygiene) totaled 670,317 increasing by 6,476 (+1.0%) from the previous month. SSI expenditures in August 2009, totaled \$379,046,144 increasing by approximately \$8.5 million (+2.3%) from July 2009.

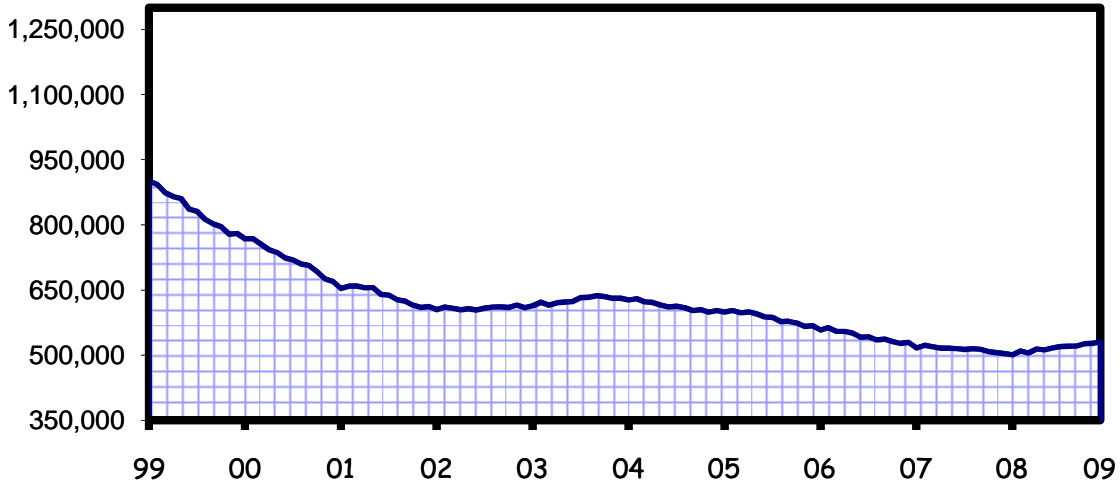

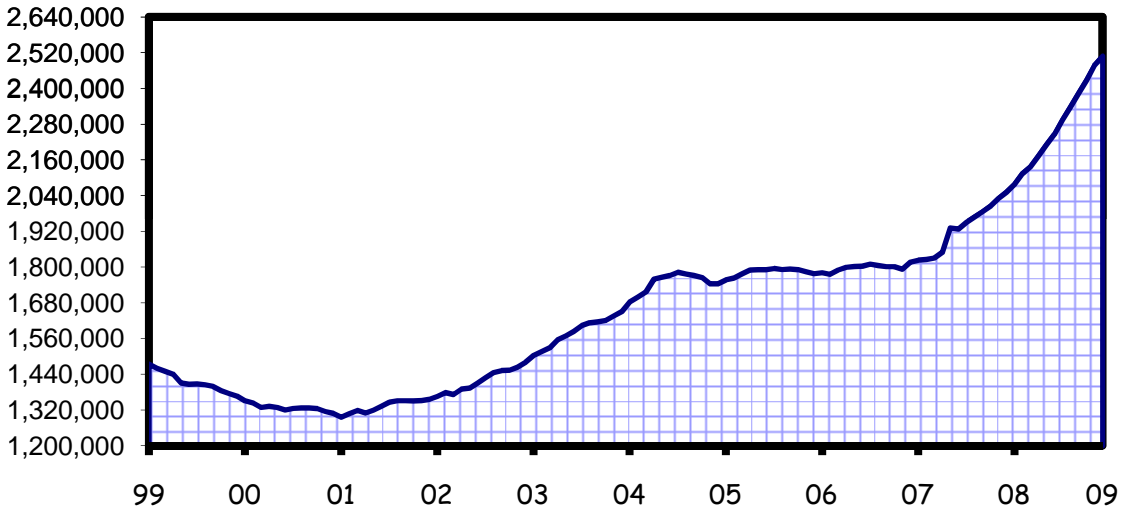

TEMPORARY ASSISTANCE RECIPIENTS**

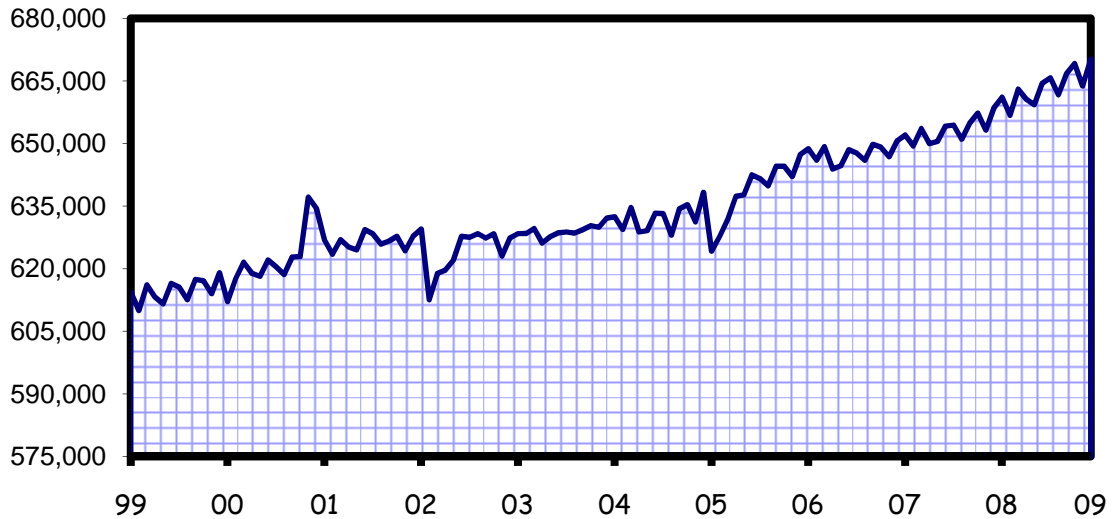


FOOD STAMPS RECIPIENTS
