MAY 2010

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 540,706 in May 2010, decreasing by 2,762 (-0.5%) from the previous month. Related expenditures totaled \$167,102,519 in May 2010, decreasing by approximately \$8.2 million (-4.7%) over April 2010.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,799,734 in May 2010, increasing by 23,859 (+0.9%) over April 2010. Food Stamps expenditures totaled \$423,947,214 in May 2010, increasing by approximately \$3.4 million (+0.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For May 2010, SSI recipients (including Mental Hygiene) totaled 678,564 increasing by 6,523 (+1.0 %) from the previous month. SSI expenditures in May 2010 totaled \$384,322,968 increasing by approximately \$5.7 million (+1.5%) from April 2010.

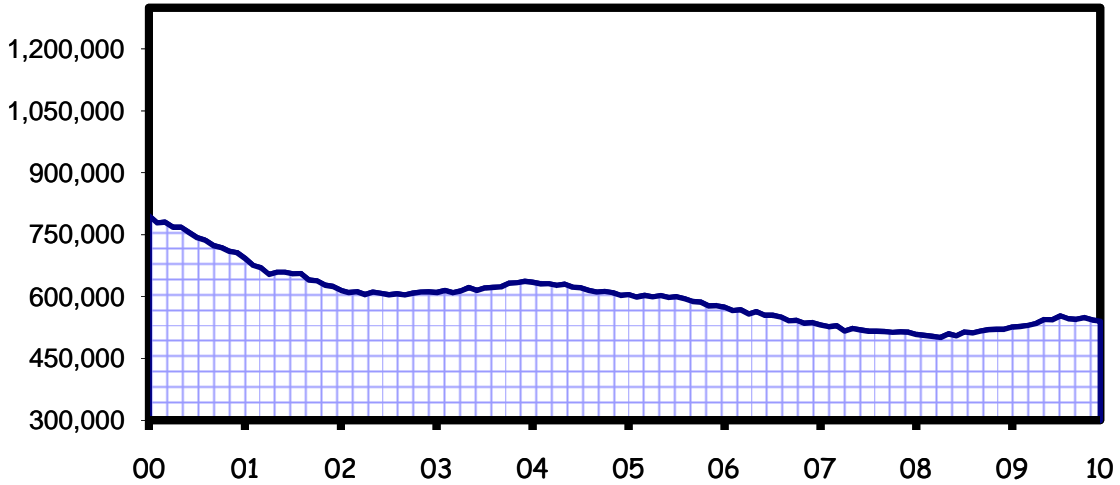

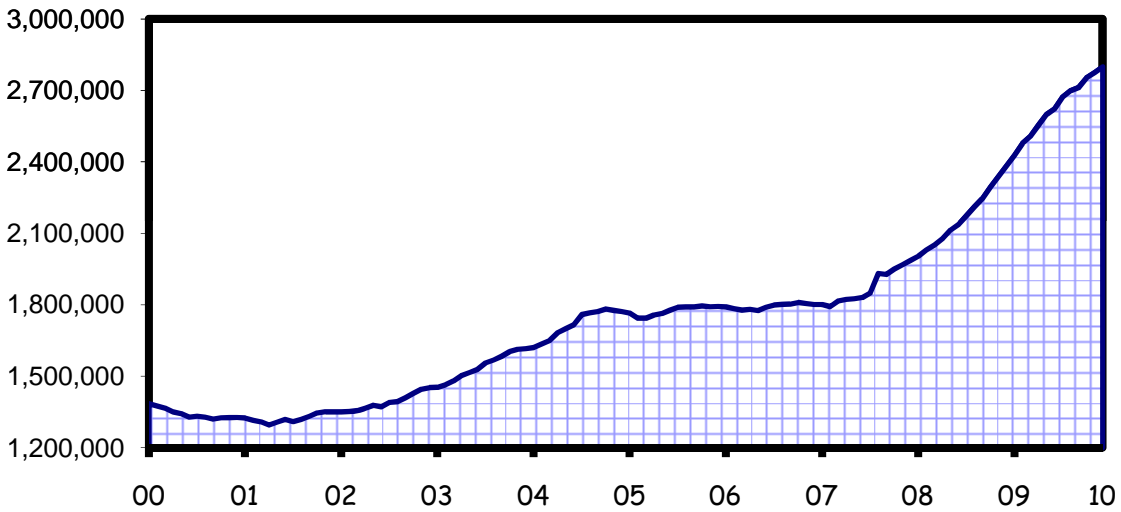

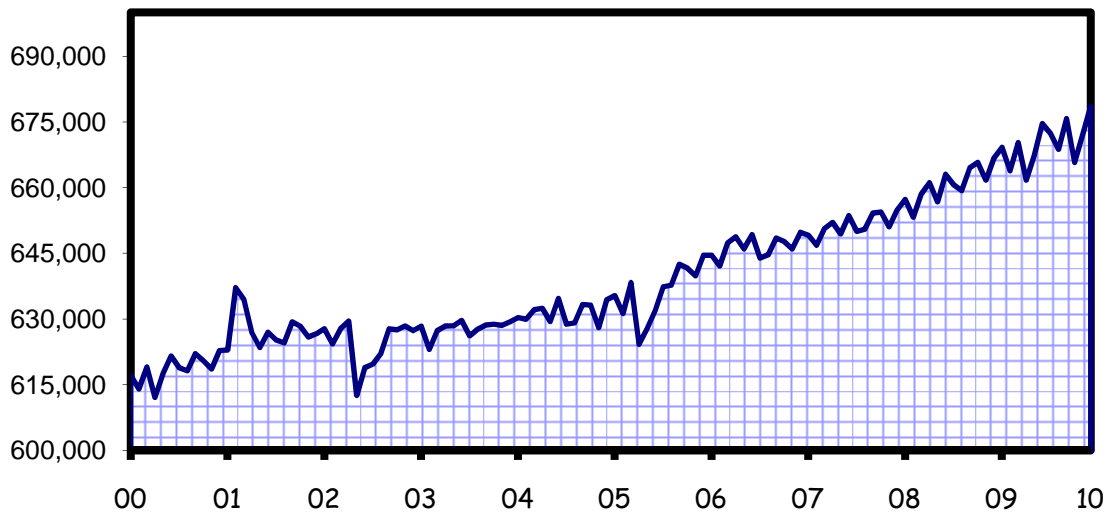
