# Temporary and Disability Assistance Statistics **AUGUST 2010**

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 544,146 in August 2010, increasing by 2,871 (+0.5%) from the previous month. Related expenditures totaled \$177,523,072 in August 2010, increasing by \$2.0 million (+1.1%) over July 2010.

## Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,874,189 in August 2010, increasing by 13,795 (+0.5%) over July 2010. Food Stamps expenditures totaled \$434,957,495 in August 2010, increasing by approximately \$3.5 million (+0.8%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For August 2010, SSI recipients (including Mental Hygiene) totaled 683,558 increasing by 7,556 (+1.1%) from the previous month. SSI expenditures in August 2010 totaled \$389,668,775 increasing by approximately \$10.6 million (+2.8%) from July 2010.

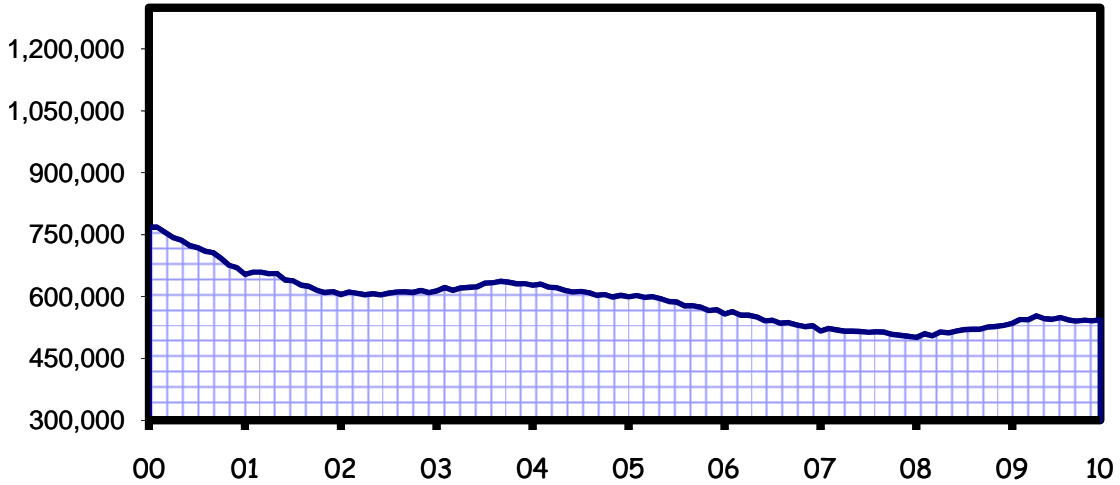

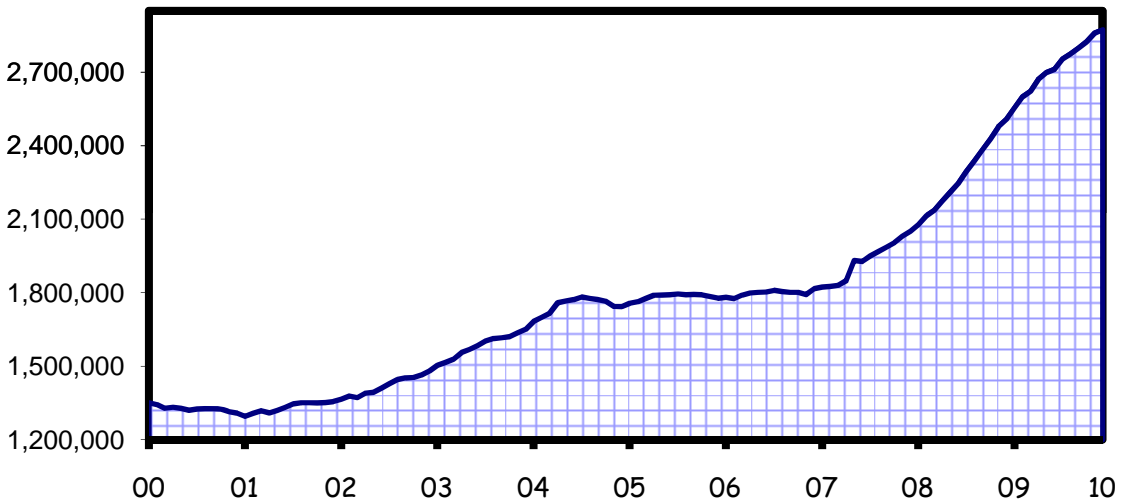

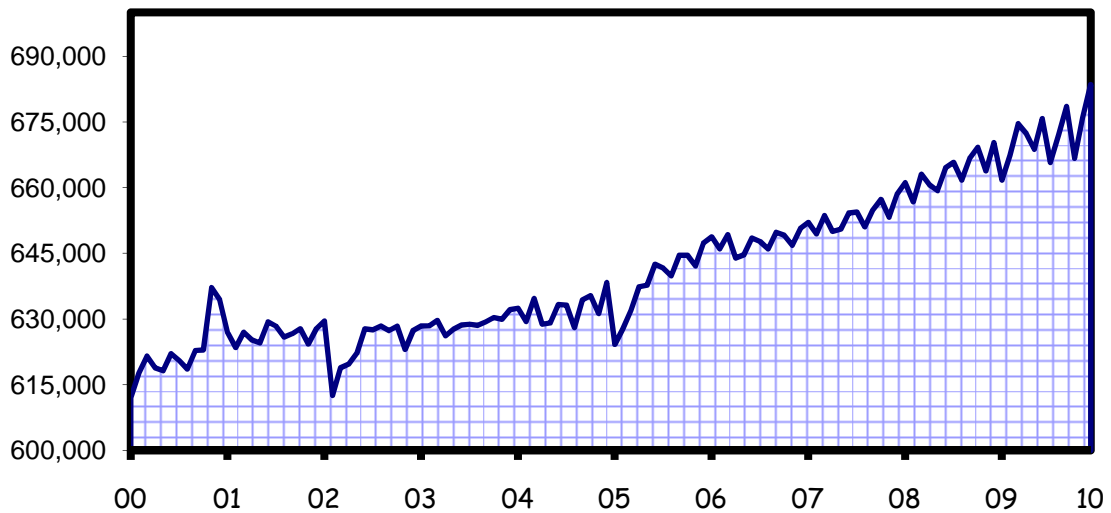
