Temporary and Disability Assistance Statistics **SEPTEMBER 2010**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 547,592 in September 2010, increasing by 3,446 (+0.6%) from the previous month. Related expenditures totaled \$176,750,149 in September 2010, decreasing by \$772,923 (-0.4%) over August 2010.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,895,995 in September 2010, increasing by 21,806 (+0.8%) over August 2010. Food Stamps expenditures totaled \$437,906,115 in September 2010, increasing by approximately \$3.0 million (+0.7%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For September 2010, SSI recipients (including Mental Hygiene) totaled 674,903 decreasing by 8,655 (-1.3%) from the previous month. SSI expenditures in September 2010 totaled \$378,883,598 decreasing by approximately \$10.8 million (-2.8%) from August 2010.

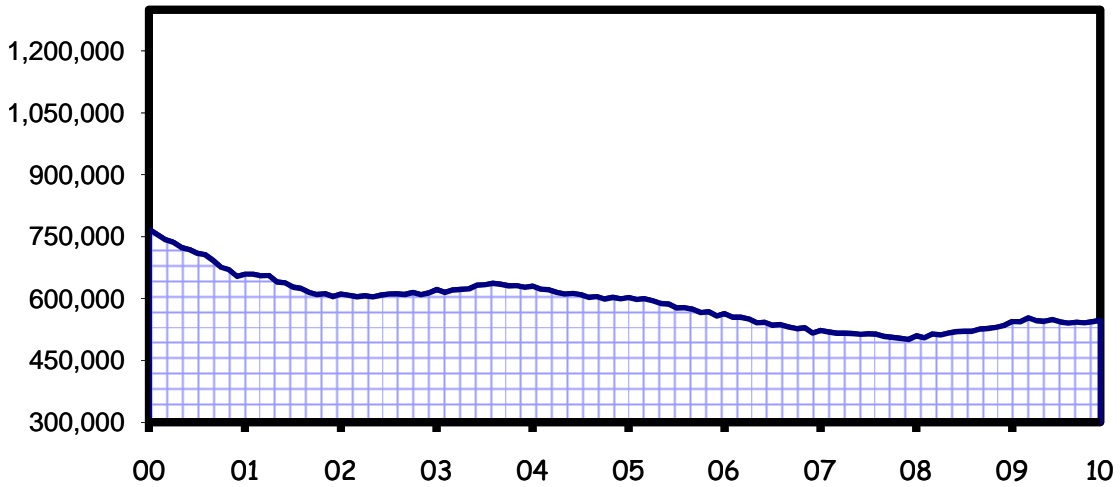

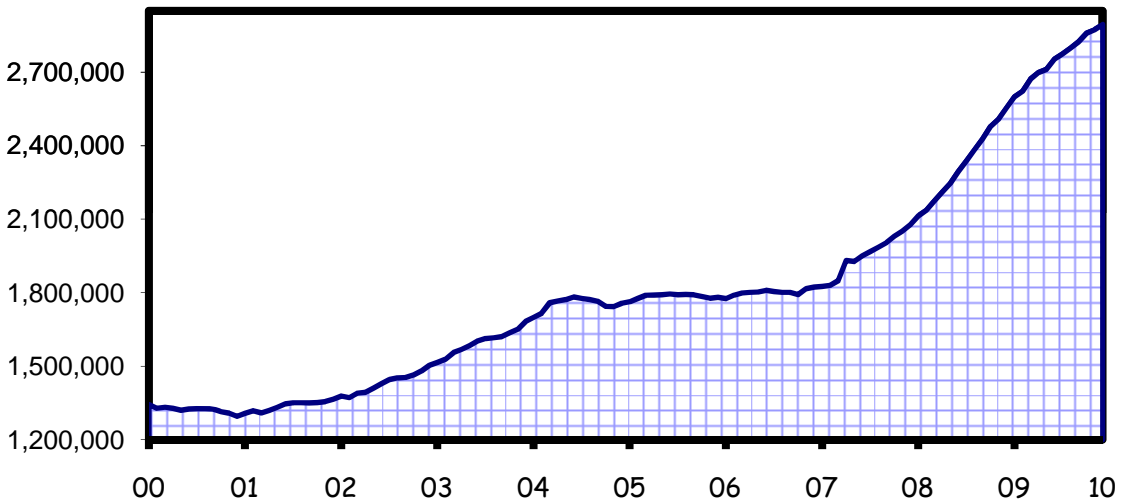

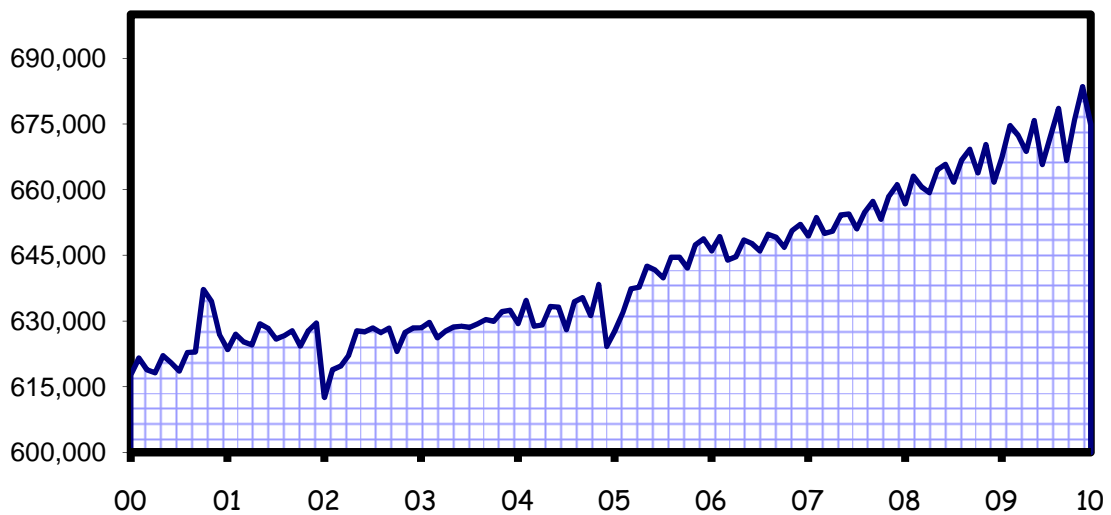
