Temporary and Disability Assistance Statistics **JULY 2011**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 561,076 in July 2011, decreasing by 9,173 (-1.6%) from the previous month. Related expenditures totaled \$172,964,100 in July 2011, decreasing by approximately \$5.8 million (-3.3%) over June 2011.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,043,751 in July 2011, increasing by 7,926 (+0.3%) from the previous month. Food Stamp expenditures totaled \$451,439,268 in July 2011, increasing by 792,069 (+0.2%) over June 2011.

Supplemental Security Income

Supplemental Security Income: For July 2011, SSI recipients (including Mental Hygiene) totaled 692,404, decreasing by 25 (-0.004%) from the previous month. SSI expenditures in July 2011 totaled \$388,617,982 decreasing by approximately \$1.4 million (-0.4%) over June 2011.

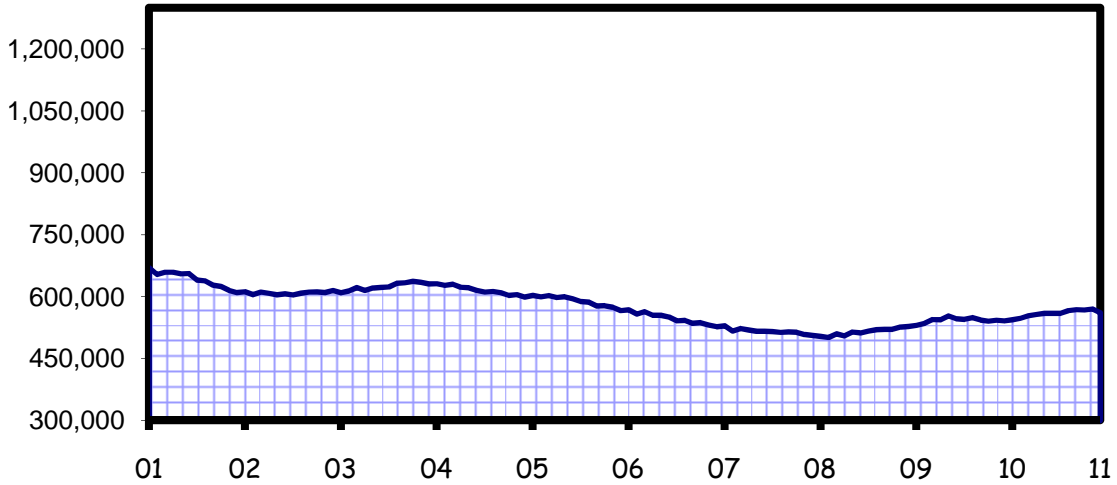

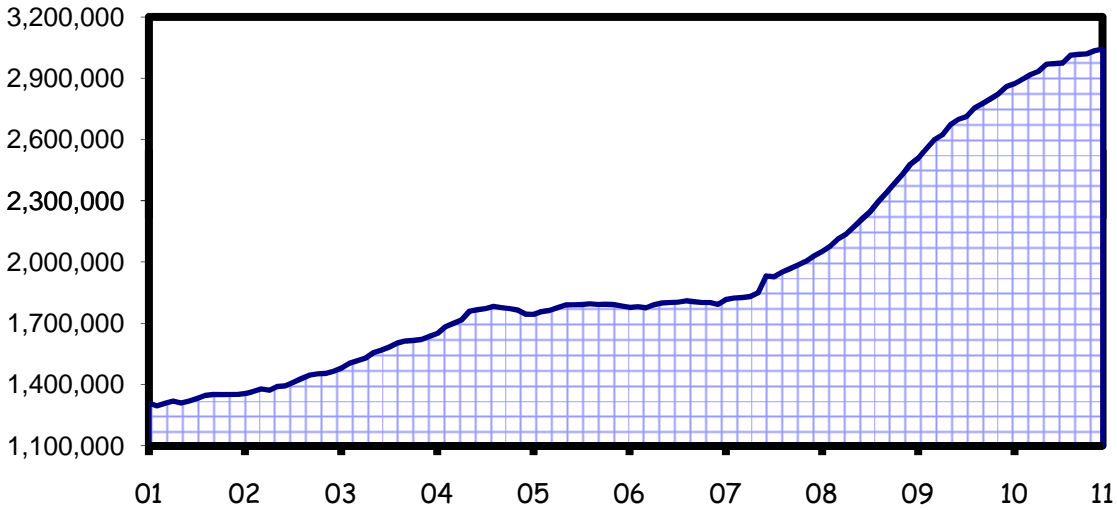

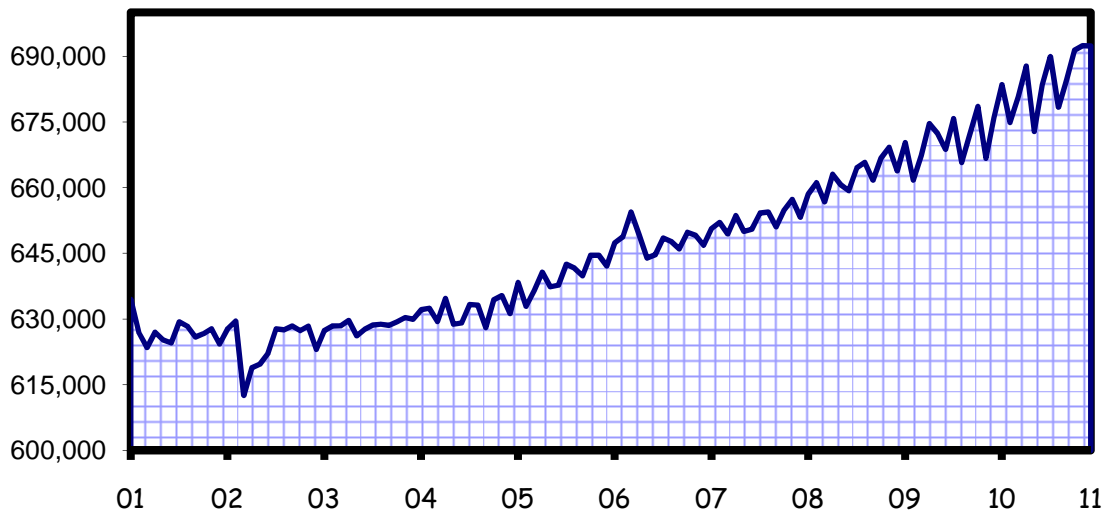
