Temporary and Disability Assistance Statistics

JANUARY 2014

Temporary Assistance

Temporary Assistance recipients totaled 560,991 in January 2014, decreasing by 5,433 (-1.0%) from the previous month. Related expenditures totaled \$178,687,786 in January 2014, decreasing by approximately \$4.5 million (-2.5%) over December 2013.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,148,532 in January 2014, decreasing by 9,844 (-0.3%) from the previous month. Related expenditures totaled \$431,527,983 in January 2014, decreasing by approximately \$4.0 million (-0.9%) over December 2013.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 699,492 in January 2014, increasing by 5,921 (+0.9%) from the previous month. Related expenditures totaled \$407,925,550 in January 2014, increasing by approximately \$3.6 million (+0.9%) over December 2013.

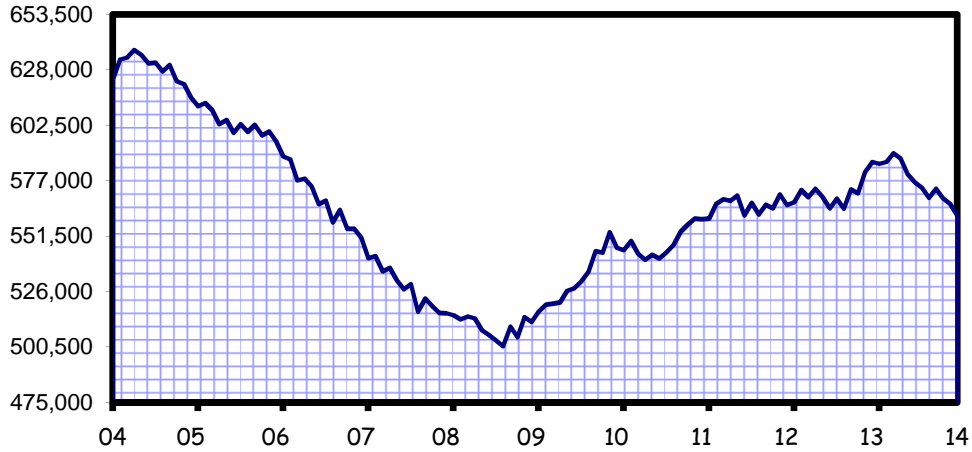

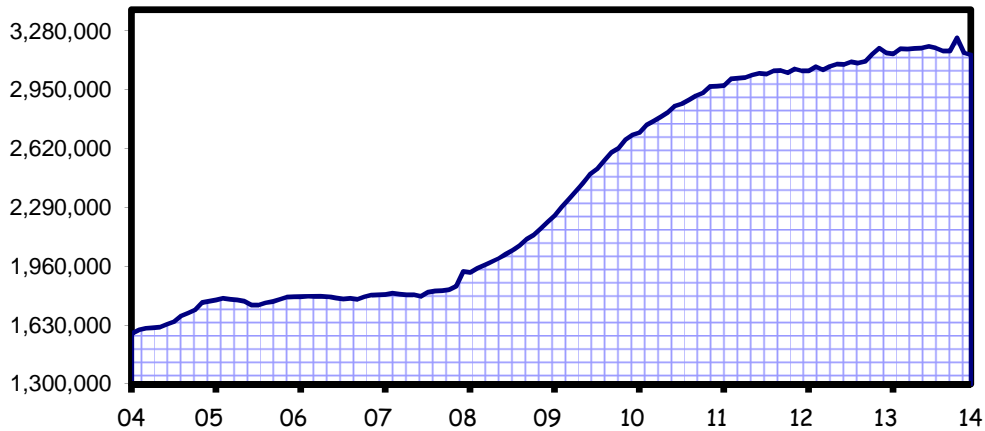

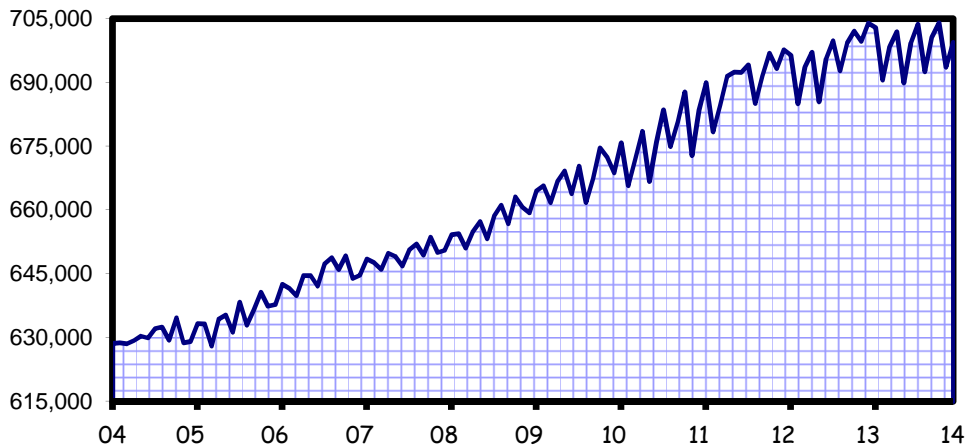
