Temporary and Disability Assistance Statistics

March 2014

Temporary Assistance

Temporary Assistance recipients totaled 566,456 in March 2014, increasing by 4,931 (+0.9%) from the previous month. Related expenditures totaled \$187,042,939 in March 2014, increasing by approximately \$8.5 million (+4.8%) over February 2014.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,109,524 in March 2014, decreasing by 4,890 (-0.2%) from the previous month. Related expenditures totaled \$428,903,945 in March 2014, increasing by approximately \$1.7 million (+0.4%) over February 2014.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 692,289 in March 2014, decreasing by 10,354 (-1.5%) from the previous month. Related expenditures totaled \$405,007,352 in March 2014, decreasing by approximately \$7.3 million (-1.8%) over February 2014.

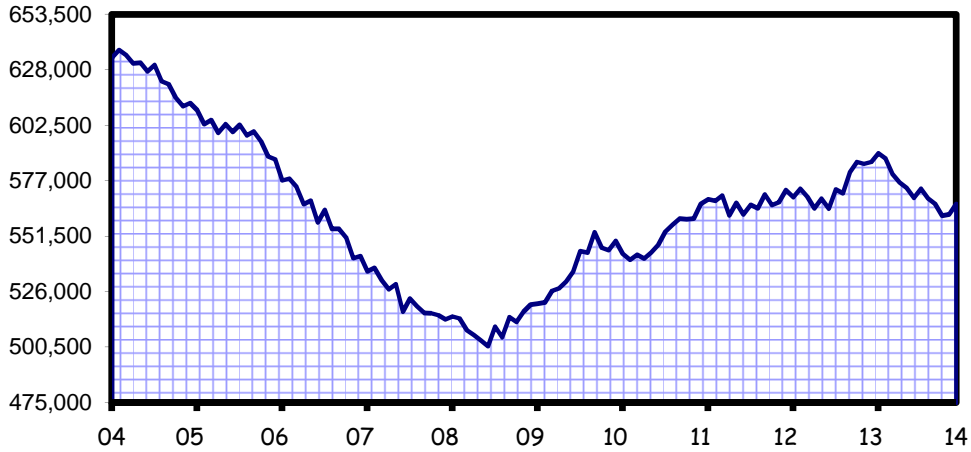

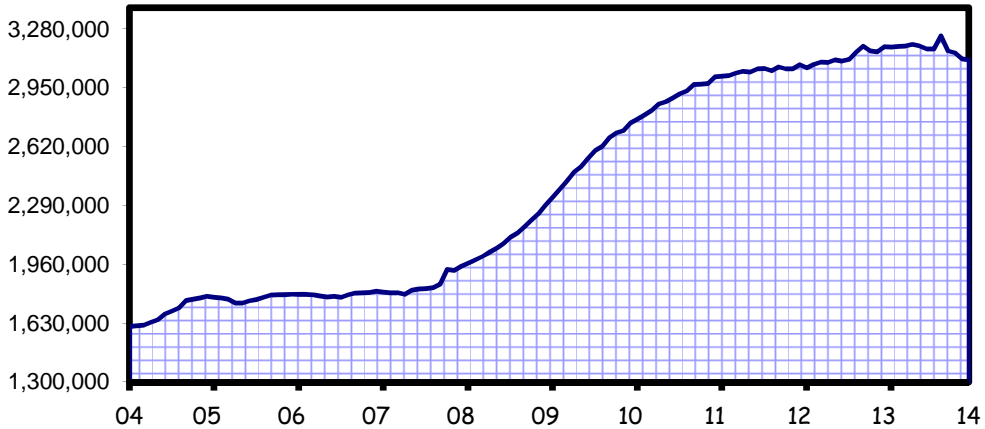

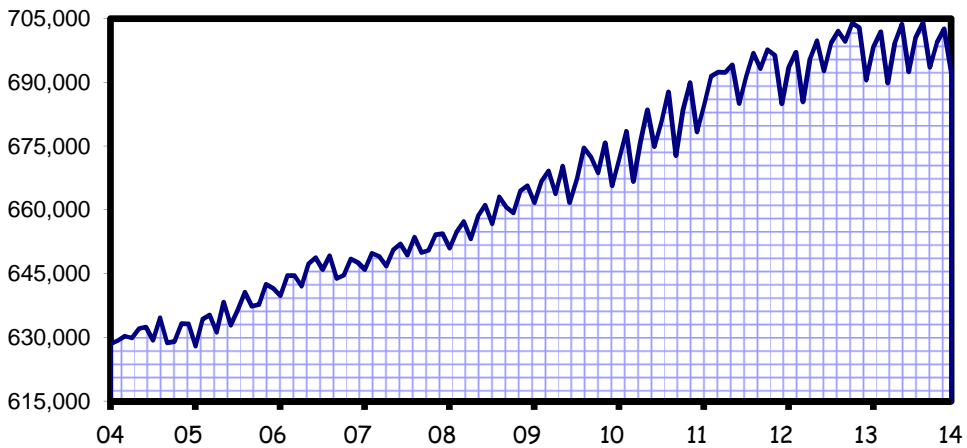
