Temporary and Disability Assistance Statistics

SEPTEMBER 2015

Temporary Assistance

Temporary Assistance recipients totaled 573,074 in September 2015, increasing by 275 (+0.05%) from the previous month. Related expenditures totaled \$185,917,015 in September 2015, increasing by approximately \$3.0 million (+1.6%) over August 2015.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,001,849 in September 2015, increasing by 241 (+0.01%) from the previous month. Related expenditures totaled \$421,223,071 in September 2015, decreasing by \$355,845 (-0.1%) over August 2015.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 706,894 in September 2015, decreasing by 3,804 (-0.5%) from the previous month. Related expenditures totaled \$421,653,160 in September 2015, decreasing by approximately \$1.5 million (-0.3%) over August 2015.

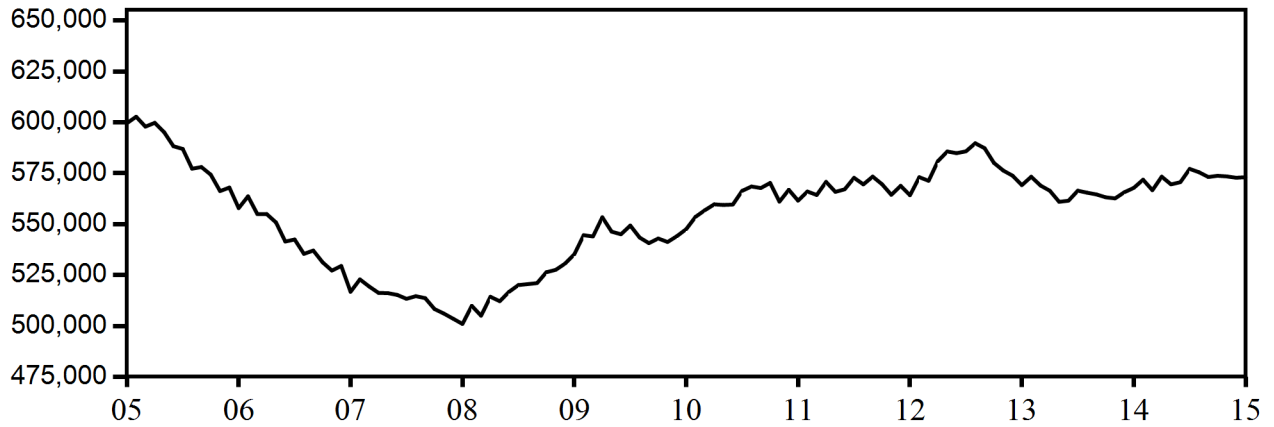

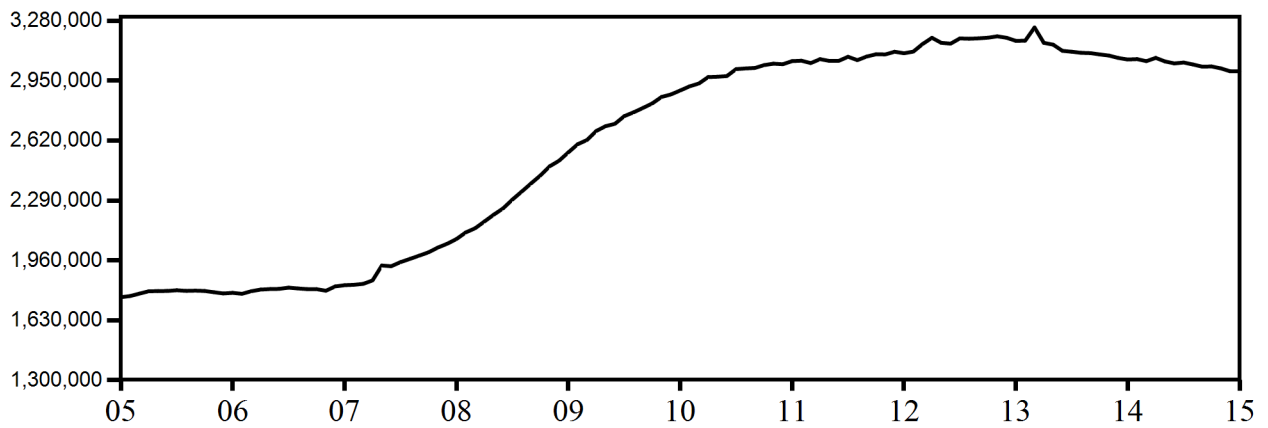

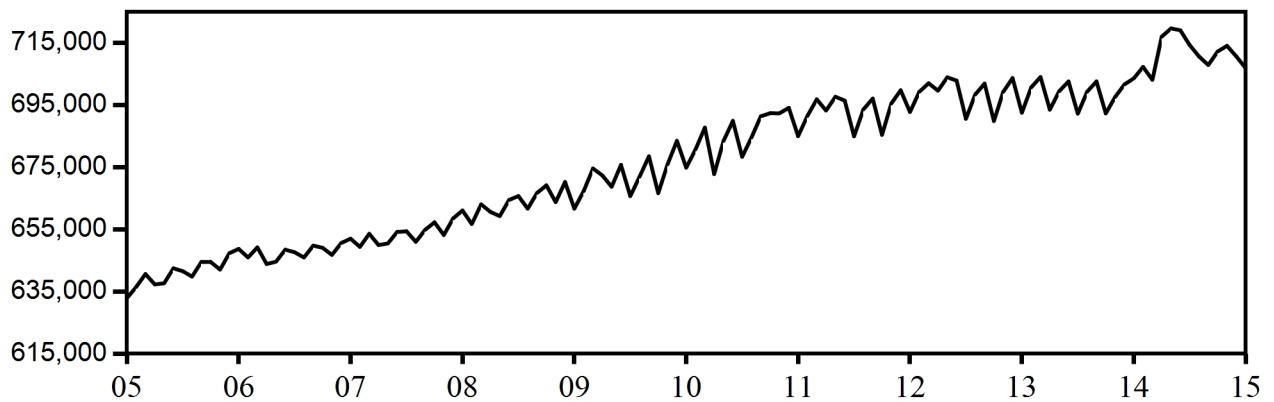
