Temporary and Disability Assistance Statistics

FEBRUARY 2016

Temporary Assistance

Temporary Assistance recipients totaled 570,207 in February 2016, increasing by 3,820 (+0.7%) from the previous month. Related expenditures totaled \$187,914,734 in February 2016, increasing by approximately \$9.8 million (+5.5%) over January 2016.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 2,971,963 in February 2016, decreasing by 3,073 (-0.1%) from the previous month. Related expenditures totaled \$411,698,419 in February 2016, increasing by \$454,375 (+0.1%) over January 2016.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 705,304 in February 2016, increasing by 428 (+0.1%) from the previous month. Related expenditures totaled \$416,784,683 in February 2016, increasing by approximately \$3.3 million (+0.8%) over January 2016.

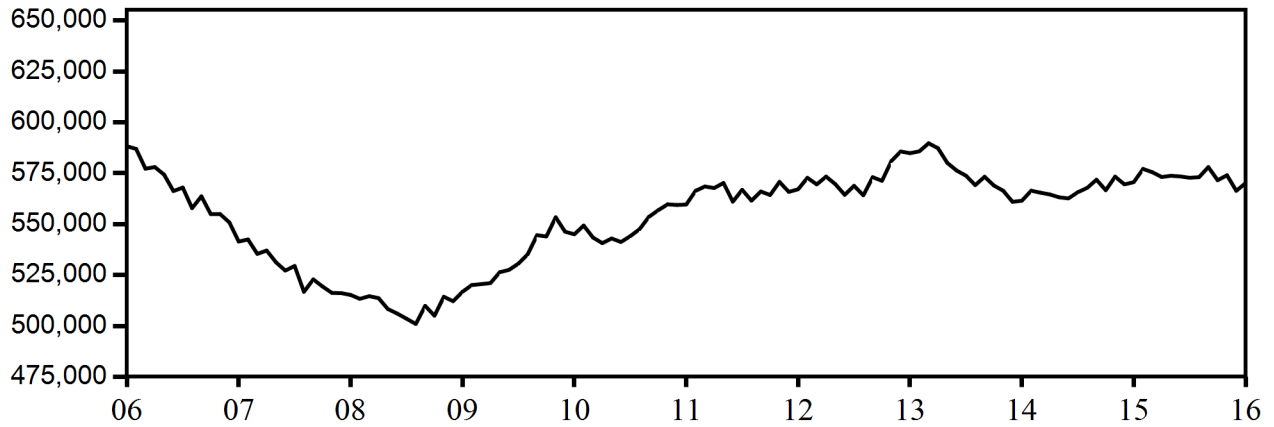

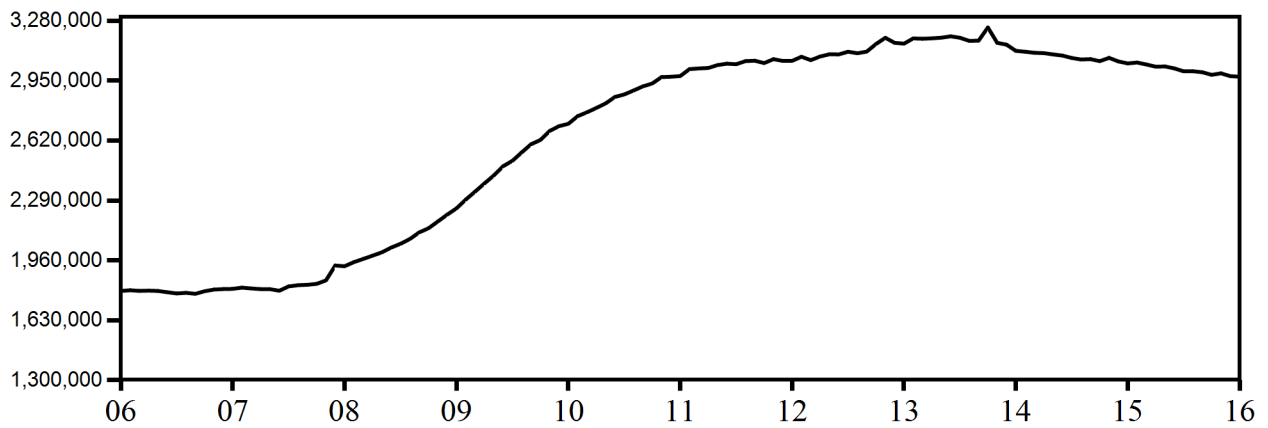

TEN YEAR TREND

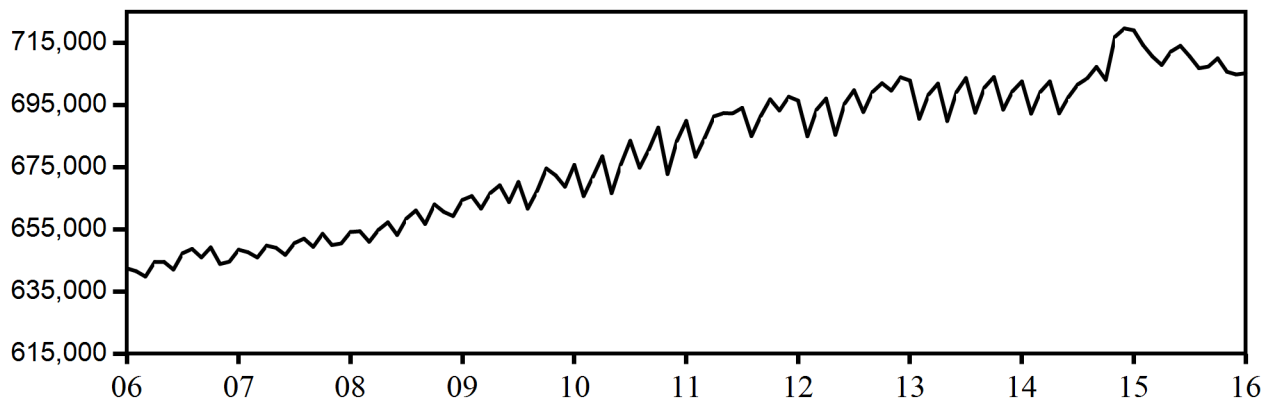
