Temporary and Disability Assistance Statistics

MARCH 2016

Temporary Assistance

Temporary Assistance recipients totaled 570,613 in March 2016, increasing by 406 (+0.1%) from the previous month. Related expenditures totaled \$193,030,661 in March 2016, increasing by approximately \$5.1 million (+2.7%) over February 2016.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 2,972,806 in March 2016, increasing by 843 (+0.03%) from the previous month. Related expenditures totaled \$414,102,483 in March 2016, increasing by approximately \$2.4 million (+0.6%) over February 2016.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 705,274 in March 2016, decreasing by 30 (< -0.01%) from the previous month. Related expenditures totaled \$418,553,960 in March 2016, increasing by approximately \$1.8 million (+0.4%) over February 2016.

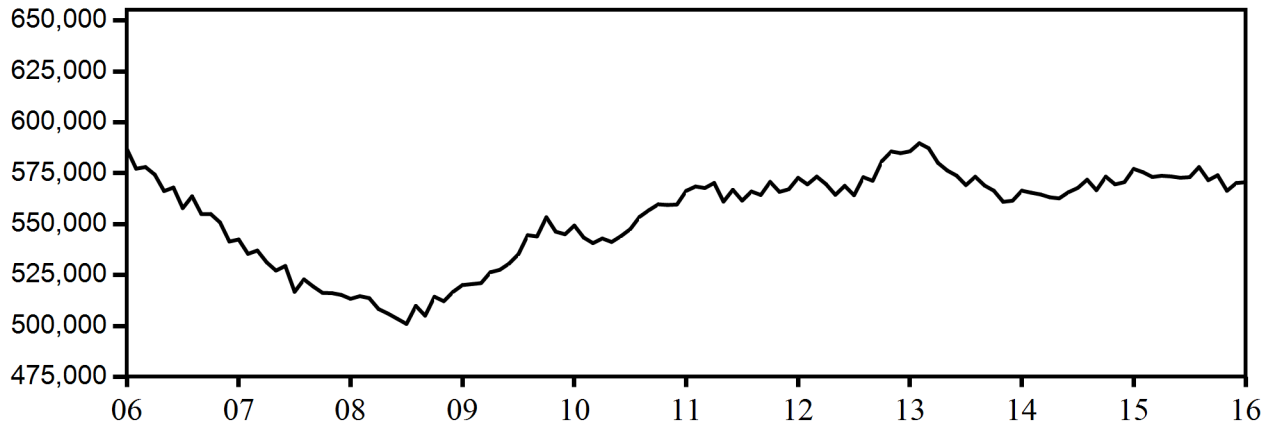

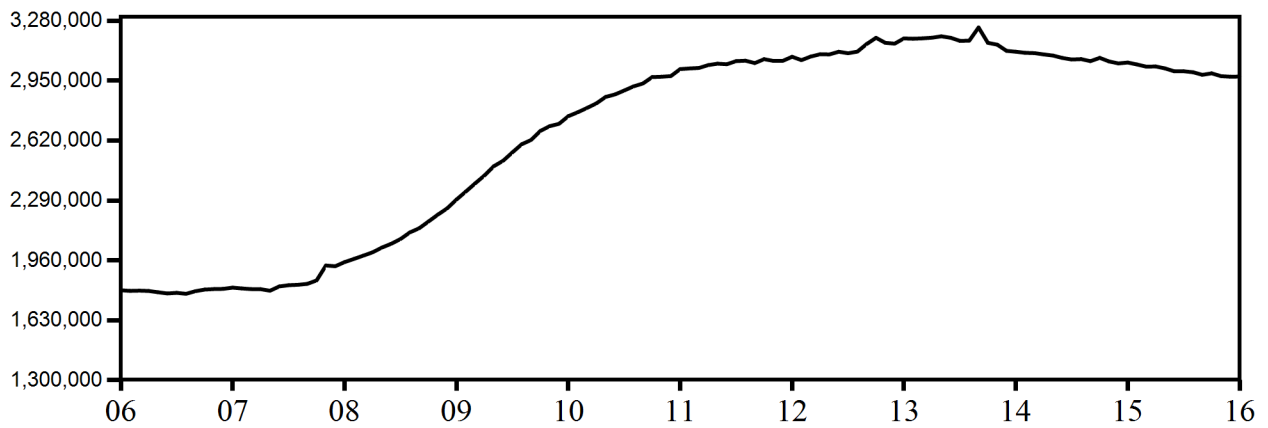

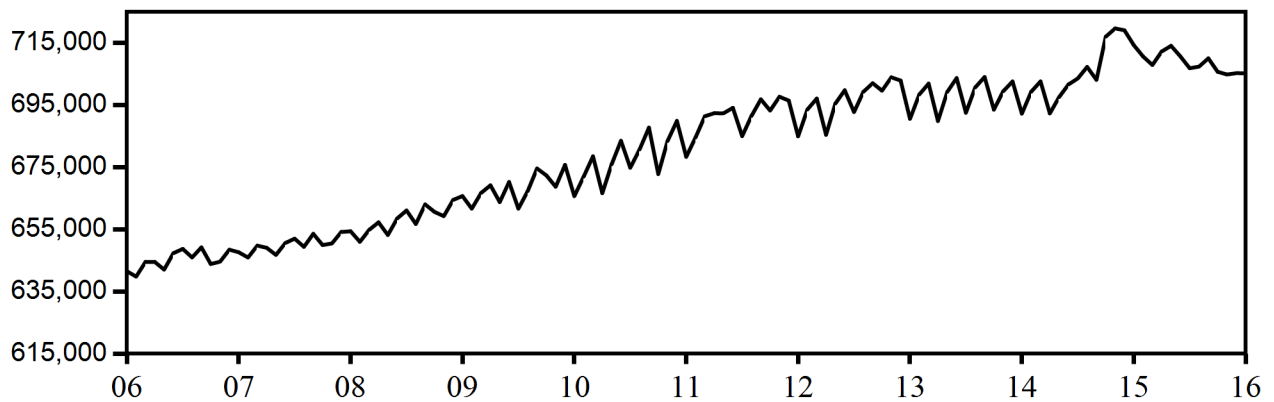
