Balance of State CoC



Background

The Point-in-Time (PIT) count is a count of sheltered and unsheltered people experiencing homelessness on a single night in January. The U.S. Department of Housing and Urban Development (HUD) requires that Continuums of Care conduct an annual count of people experiencing homelessness who are sheltered in emergency shelter, transitional housing, and Safe Havens on a single night. Continuums of Care also must conduct a count of unsheltered people experiencing homelessness every other year. Each count is planned, coordinated, and carried out locally. The New York State Balance of State Continuum of Care (NYS BoS CoC) conducted the PIT Count on January 26, 2022.


Notes and Takeaways

The NYS BoS CoC's overall homeless count increased substantially in 2022, up 78% from the year prior. Sheltered persons accounted for 93% of the county's PIT total. The homeless population was predominately white, male, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. The count revealed 82 chronically homeless individuals, 53 unaccompanied youth, 26 persons in parenting youth households, 52 adults with a serious mental illness (SMI), 35 adult victims of domestic violence, 23 adults with a substance use disorder (SUD), and 18 veterans.


Providers in the NYS BoS CoC report the following trends in their communities related to the 2022 PIT count and homeless delivery system:

- Clients are presenting with complex mental health, substance use and medical issues, making permanent placements difficult to secure.
- There is a widespread shortage of affordable housing.
- Units that are available are in poor shape and unable to pass HUD inspection.
- Some landlords in the community have found alternate ways around the eviction moratorium, including calling code enforcement on their own apartments, or selling their properties. Tenants may not know their rights and vacate the unit without seeking eviction prevention assistance.
- Landlords are placing more restrictions and fees on new incoming tenants.
- Seniors living in their own homes may have their utilities shut off or have frozen pipes and therefore seek assistance.
- Child Protective Services (CPS) and/or Domestic Violence agencies are requesting people leave their homes to separate a perpetrator from their families. DV shelters have returned to pre-pandemic volume of clients.
- There is an overflow of homeless clients from nearby counties.
- Providers have more funds available to conduct outreach and connect people with housing services.




Cattaraugus County's overall homeless count increased substantially in 2022, up 200% (42 people) from the year prior. Sheltered persons accounted for 98% of the county's PIT total. The homeless population was predominantly white, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. Among the 63 homeless individuals, 34 were female, 28 were male, and one was a gender other than singularly female/male. The count revealed seven unaccompanied youth, four veterans, six adult victims of domestic violence, and six adults with SMI.



Notes and Takeaways

After decreasing sharply between 2019 and 2021, Clinton County's overall homeless count increased modestly in 2022, up 17% (15 people) from the year prior. Sheltered persons accounted for 100% of the county's PIT total. The homeless population was predominantly white, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. The count revealed 21 chronically homeless adults and/or children, 20 adults with SMI, and 7 veterans.

Notes:

- In late 2021, MHAB changed programming and no longer accepted residents based on HUD homeless criteria, and therefore MHAB was not included in the 2022 PIT.
- ETC's Emergency Shelter had reduced capacity due to 3 units temporarily unavailable. The program also reported smaller families in the units, resulting in a smaller census.



Notes and Takeaways

Fulton County's overall homeless count increased dramatically in 2022, up more than 460% (42 people) from the year prior. Unsheltered persons accounted for 67% of the county's PIT total — considerably higher than all other BoS counties. The homeless population was predominantly white, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. Among the 51 homeless individuals, 33 were male and 18 were female. The count revealed 25 chronically homeless adults and/or children — 23 of whom were unsheltered — along with 10 unaccompanied youth and two veterans.


- In 2021, Fulton County formed a Street Outreach (SO) team funded by ESG-CV, which located dozens of people sleeping in abandoned buildings. The dedicated SO team was able to conduct targeted outreach and connect unsheltered people with housing and social services.
- A Warming Shelter was established in Fulton County one week before the PIT Count.







Notes and Takeaways

Herkimer County experienced a marked increase in its reported homeless population in 2022, up 26 people (163%) from the year prior. Sheltered persons accounted for 100% of the county's PIT total. The homeless population was predominately white, male, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. Adults with SMI (10) and SUD (10) were the most common subpopulations. Herkimer County did not report any homeless veterans.




Montgomery County's overall homeless count increased considerably in 2022, up 114% (33 people) from the year prior. Sheltered persons accounted for 97% of the county's PIT total. The homeless population was predominantly white, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24 — however, the percentage of homeless individuals under 18 (32%) was higher than most other counties. Among the 62 homeless individuals, 35 were male and 27 were female.






Putnam County's overall homeless count decreased substantially in 2022, down 38% (16 people) from the year prior. Sheltered persons accounted for 85% of the county's PIT total. The homeless population was predominantly white, non-Hispanic/non-Latin(a)(o)(x), and over the age of 24. Among the 26 homeless individuals, 13 were male, 11 were female, and two were transgender.




After decreasing slightly in 2020 and 2021, Schoharie county's overall homeless count increased by 47% in 2022, up 23 people from the year prior. Sheltered persons accounted for 100% of the county's PIT total. The homeless population was predominately white and non-Hispanic/non-Latin(a)(o)(x). The count included slightly more females than males, while the age distribution was split evenly between those under 24 years old and those 25+.






After falling by more than 50% since 2019, Sullivan County's overall homeless count more than doubled in 2022, up 100 people from the year prior. Sheltered persons accounted for 100% of the county's PIT total. The homeless population was predominantly non-Hispanic/non-Latin(a)(o)(x), over the age of 24, and white; however, the Black, African American, or African population (26% of total) was disproportionately represented compared to the population at large.


Notes:
