## **Steering Committee Voting Actions**

## June Meeting Minutes

The June Steering Committee minutes were reviewed. A motion to approve was made by Jodi Fuller and seconded by Adam Anderson. All attendees were in favor, none opposed.

## **New Steering Committee Members**

Noel Feik from Crossroads Inn was nominated to the Steering Committee by the Otsego County Local Planning Body (LPB). A motion to accept Noel to the Steering Committee was made by Deb Worden and seconded by Ashley Brody. All attendees were in favor, none opposed.

### **Unite Us Platform Demonstration**

Commissioner John Liddle and Deborah Worden provided a demonstration of the Unite Us platform, which is a closed loop referral system that is being utilized by several Social Care Networks.

# Youth Advisory Board (YAB) Presentation

Liddy Bargar from the Human Services Coalition of Tompkins County (NY-510) spoke about their experience forming and facilitating a YAB and Youth Homelessness Demonstration Program (YHDP).

### **FY2025 CoC NOFO**

In July, HUD sent out a notification that there will be a CoC NOFO in FY2025. It is unknown at this time as to the impact on the prior year's two-year competition cycle. More details will be released in the future.

# **Committee/Program Updates**

## Lived Experience Advisory Board (LEAB)

The LEAB presented a Tenant's Rights Training in July to CoC providers and tenants in housing programs. This training will be offered regularly through the CoC's training series.

## Balance of State (BoS) Racial Equity Committee

The BoS Racial Equity Committee developed a Steering Committee Board Matrix to assess the skills and knowledge sets of BoS leadership. The committee is also making updates to the Diversity Assessment Tool.

Beginning in October, HUD data standards will be updated. Gender and Sexual Orientation will no longer be required or included in federal reporting.

# **LPB Updates**

## Clinton

DSS Commissioner Christine Peters has accepted a new position as the Clinton County Administrator. Gretchen Crowningshield is now serving as the Acting Commissioner.

## Montgomery

Mongomery County is preparing for the Warming Center to open in the Fall.

# Otsego

Otsego County had their first LPB Meeting as part of the BoS. Opportunities for Otsego's Emergency Shelter is almost at capacity as is their Rapid Rehousing Program. Their Domestic Violence Intervention Program is losing federal funding.

### Putnam

Search for Change submitted two Empire State Supportive Housing Initiative (ESSHI) applications. They also received a grant to expand their scattered site supportive housing program.

### Sullivan

Sullivan County's emergency housing numbers have decreased by ten more individuals.
